REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

MARCH 22, 2006

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, March 22, 2006 at 1:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present.

Chairman Eisel announced that Deputy County Attorney Porter Kirkwood would be sitting in for County Attorney Richard Spinney who is on vacation.

Mr. Donnelly offered the invocation.

Mr. Smith led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted with the following notation on page four, first paragraph, from Mr. Woodford. He pointed out that his comment should have read the river, not the dam, was very low.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Director of Public Health Bonnie Hamilton who introduced Edith Sabatini as employee of the month.

Ms. Sabatini was hired in 1999 and works primarily as a service coordinator and Early Intervention Official Designee for the Early Intervention (EI) program. Mrs. Hamilton explained that this program serves children under three with developmental disabilities. Ms. Sabatini works with families and community partners to identify children that may have special needs. In addition to the EI program, Ms. Sabatini is responsible for the clinical portion of the lead poisoning prevention program which involves identifying children with elevated blood lead levels and providing education and follow up to the families. In addition, Ms. Sabatini is a member of the Heath Education Committee and has been the chairman of the annual Public Health Week/Employee Recognition Week.

Ms. Sabatini has done an outstanding job with anything she has been asked to do, adding she has taken it upon herself to streamline some of the agency paperwork. Mrs. Hamilton said it been wonderful having Ms. Sabatini on board and she is very proud to give her this honor.

Mrs. Hamilton presented Ms. Sabatini with a \$100.00 Savings Bond and thanked her for

her dedication. Chairman Eisel commented that there is something to be said for anyone who can streamline paperwork and presented her with the Certificate of Employee of the Month and thanked her for her dedicated service.

Ms. Sabatini expressed her thanks for the honor and said she feels truly blessed for the county she lives in, the people she works for and the people she works with.

Chairman Eisel granted privilege of the floor to Mr. Haynes, who on behalf of the Board, congratulated the South Kortright girls varsity basketball team for winning the Delaware League in Section 4 Class D titles. He also noted that on Sunday, March 19, 2006 they won the New York State Public High School Athletic Associate Class D State Basketball Championship. He added this is a great achievement.

Chairman Eisel granted privilege of the floor to Mr. Hynes who introduced the Democratic Commissioner of Elections, William Buccheri and the Republican Commissioner of Elections, William Campbell, to discuss the Help America Vote Act (HAVA). Mr. Hynes explained that the county will now be running elections. He pointed that New York State has not yet decided on the type of machines that will be used, therefore, discussion on the machines will be sometime in the future. He added that the Board of Elections Committee continues to meet to keep abreast of what is going on.

Mr. Buccheri stated that as of January 15, 2006 all election operations are now being run by the county. As a result, the Commissioners needed to establish a fair and equitable formula for determining what the county will be paying the inspectors and custodians.

Mr. Campbell stated that the HAVA is a federal mandate and commented on a quote he recently read, "that the Help America Vote Act is a solution searching desperately for a problem." He pointed out that we do not have a problem in this county or in this state with elections but, this did not stop the federal government from telling us that we must comply.

He pointed out that as a result of HAVA the Board of Supervisors must now set the fees that will be paid to the inspectors and custodians, adding these changes effect in excess of 200 people throughout the county each time an election is held. Commissioner Campbell made the following fee suggestions to the Board. Inspectors for the primary elections to be paid \$140, inspectors for the general elections be paid \$190, machine custodians be paid \$60 per machine and, the fee for going to another town would be \$85. In addition, he suggested, that in order to keep things simple, no mileage or meals would be paid.

Prior to deciding on the above fees, Mr. Campbell stated that the Commissioners met with each of the towns and researched what other counties were doing. He said that the fees also take into consideration what they believe the needs will be in the future.

Mr. Buccheri pointed out the county has been allowed \$27,000 for training on the new machines and \$531,000 for the purchase of the new machines, adding that he figures this amount

will buy 65 units. He said the county will need 69 or 70 machines in order to have extras in case of emergency. He added there is the possibility of receiving another five percent from the state.

Chairman Eisel remarked that he believed the federal money was going to pay for all the machines. Mr. Buccheri replied that the statement was that the federal government was going to pay 95 percent and the state may pay the other five percent. Depending on what the machines cost the funding may be enough to purchase all the units.

Chairman Eisel commented that the town of Harpersfield has two custodians, questioning whether he will have those people in the future. Mr. Buccheri explained that all the programming will be done at the county level at the Board of Elections and that the custodians will be transporters from the office of the Board of Elections to the polling locations.

Mr. Campbell added a custodian in Harpersfield will no longer be able to set the machine up and program it as the new law states "that in a central location the county must program all machines that go out". He pointed out there are 65 machines and 41 polling places, adding we are now wrestling with how we will deliver and then bring back all those machines as they cannot be left anywhere.

In reply to Mr. Marshfield, Mr. Buccheri stated that it has always been the responsibility of the county to provide the poll workers, however, the towns have always helped out with this.

Mr. Campbell added that the primary and general elections will be just as they have always been because the new machines are not here, adding they are expected in 2007.

Also in response to Mr. Marshfield, Mr. Campbell stated that the county is responsible to pay the poll workers as of now. He further stated that the towns were advised to keep putting money into their budgets but, we were not sure how the money would be spent. He pointed out that some counties were using a per machine charge back system to the town, others were expanding their budget for the Board of Elections with no charge back, adding either way the taxpayers are paying for it.

In answer to Mr. Bracci and Mr. DuMond, Mr. Buccheri stated that local elections at the schools, towns and villages will also need to use the new machines, adding under the new law they are no longer allowed to use the old lever type machines. He also pointed out that under the new law the county is instructed to take ownership of the old machines.

In reply to Mr. Meredith, Mr. Campbell answered that the schools and colleges could still use the lever machines for their student council elections.

Mr. Donnelly questioned how the county was able to take ownership of the old machines when the towns paid for them. Mr. Campbell replied that he contacted Albany and was told that as of January 15, 2006 the county owns them.

In reply to Mr. Bracci, Mr. Campbell commented that the county could decide to offer one of the old machines to a school or college. Mr. Bracci questioned if the old machines could be given away. Mr. Campbell stated that the county owns them.

Mr. Donnelly asked who will be responsible for the maintenance and upkeep of these machines. Mr. Campbell answered it is the county's responsibility.

Mr. Buccheri stated in answer to Mr. Bachler, that the New York State Board of Elections has not certified any machine to date.

In reply to Chairman Eisel, Mr. Buccheri stated that if a machine in the town of Harpersfield became inoperative, it would be the county's responsibility to replace it, adding that's why we need to have the extra machines.

Mr. Buccheri stated in reply to Mr. Meredith, that on election night the machines will still be read at the town. Mr. Campbell added it will be read at the town location so that we can still get immediate unofficial results.

In answer to Mr. Donnelly, Mr. Buccheri stated that after the new system is in place, the Commissioners will go out and survey the county. He pointed out that the Board of Elections is still under a federal court order that prevents the Board of Elections from changing a polling location. Before a site can be changed it must first be inspected by the Center of Independence and then approved by the Attorney General's Office.

Mr. Campbell said that most other counties are asking the towns to select a single polling location that is ADA complaint, adding that some counties including Delaware County are going to move slowly on choosing sites. He pointed out that it is not known yet if all the machines at all the locations will have handicap accessability or if only one machine at each location will be handicap accessible. He pointed out the state formula is currently one machine per 800 voters, adding if this changes then much of what is being discussed will change.

Mr. Buccheri commented that more space may be needed at the polling sites if more machines are needed and for the voter verified paper audit. In addition it will take voters longer to vote.

In reply to Mr. Donnelly, Mr. Campbell stated that the Board of Elections will do everything in their power to allow everyone their right to vote at a convenient location. Mr. Buccheri added that the Election Commissioners, not Albany will decide on polling locations.

Chairman Eisel pointed out that voters will most likely fear the new machines and encouraged training for the new machines.

In answer to Mr. Valente, the Commissioners stated that the suggested fees and whether or not to use a charge back system must be voted on by the Board of Supervisors.

Mr. Hynes pointed out that at some time in the future there will be a need for additional help at the Board of Elections, adding that the Committee is already discussing it. The Committee would also like to make it known that the Commissioners have worked very hard on this. He added that this discussion is important information for the public.

Ms. Molé offered the following resolution and moved its adoption:

WHEREAS, surrounding our children with equal opportunities, physical activity, safety and clean air promotes children's health; and

WHEREAS, Delaware County Public Health coordinates children's programs including Early Intervention, Preschool Special Education, Children with Special Health Care Needs, the Immunization Program, the Lead Poising Prevention Program, the Car Seat and Bike Helmet Safety Program and Tobacco Control Program; and

WHEREAS, Delaware County Public Health is committed to working with parents and community partners to hold educational health fairs, promote activity programs for children provide education on bike helmet safety and car seat safety, provide helmets and car seats when necessary, decrease lead poisoning among our children and provide coordination and services to special needs populations

NOW, THEREFORE, BE IT RESOLVED, that Delaware County recognizes April 3-9, 2006 as Public Health Week.

WHEREAS, revenue from an Inter-Governmental Transfer (IGT) program is anticipated for the care of Countryside Care Center's indigent population; and

WHEREAS, this revenue may need to be returned if there is a surplus remaining at Countryside Care Center from this particular IGT; and

WHEREAS, Delaware County has a long history of subsidizing the cost of care and services at Countryside Care Center with no additional revenue from the State or Federal governments to pay for this subsidy; and

WHEREAS, it is more accurate for Delaware County to support Countryside Care Center though the Department of Social Services that has over all responsibility for Delaware County's indigent population; and

WHEREAS, modifying the 2005 budget to reflect this financial support as a loan to be repaid by Countryside Care Center is a more consistent accounting practice

THEREFORE, BE IT RESOLVED, that the following 2005 budget modification be made:

The resolution was seconded by Mr. Marshfield.

Mr. Bracci advised this is not something that was budgeted for, adding we anticipated a federal payment to reimburse us, this is just a stop gap payment.

In answer to Mr. Bachler, Commissioner Moon commented that these figures are different from last year's, adding the state's program was disapproved by the Federal HHS so we did not budget for the IGT. About three weeks ago the state plan was approved and that is why it is being brought before you today. He advised that these are net figures, adding it is a good idea to capture the federal funds owed to Countryside based on the number of medicaid days that they provide and care for in 2003 because it lowers the county subsidy for the time that they remain a county facility. He added that we wanted to adjust our books because it was not anticipated as a revenue or as an expense.

Section 2. This Local Law shall be subject to permissive referendum according to the provisions of Section 24 of the Municipal Home Rule Law.

Section 3. This Law shall take effect forty five (45) days after it shall be adopted.

The local law was seconded by Ms. Molé.

Mr. Meredith stated he is opposed to this increase due to the fact that he is aware of several problems. He pointed out that there has been a lag in compliance with the real property law, updates and corrections on taxes as well as appropriation of mortgage taxes.

Mr. Valente stated this is a department that started out in a deep hole. He pointed out that he has worked with Mr. Sabansky and he has been a big help to the town of Davenport. He added that he sees steady, regular progress being made in the department.

Mr. Hynes stated that he had the same feeling as Mr. Meredith, adding he spoke to the committee and was advised they were working on the problems.

Mr. Rowe stated that the circumstances under which Mr. Sabansky took over the department was not the best. He pointed out that he sees Mr. Sabansky quite often and notices that he is beginning to work through the papers on his desk. He added that hopefully the Committee has a handle on the problems.

Chairman Eisel also noted this has been a tough transition, adding we have tried to support him with staff and equipment. He further stated that while Mr. Sabansky may not have it totally under control he is working at it everyday.

Mr. Shelton agreed that Mr. Sabansky walked into a very serious situation. He added, when he was on the Finance Committee he did see improvements.

- Mr. Utter stated the complexity of the problems the towns are having today far outweigh any of the problems faced 10 or15 years ago, adding it behooves those on the town planning board to have the expertise of Ms. Franzese and her staff. He stated it is a godsend we have the Planning Department that we have today.
- Ms. Molé thanked Ms. Franzese and her department for the work the department does for the county and for the town of Bovina, adding Ms. Franzese is not only intelligent but has a backbone as well.
- Mr. Donnelly stated there isn't a department that hasn't benefitted in some way from the efforts of the Planning Board and Ms. Franzese's direction. He added that without the help of Ms. Franzese and her staff New York City would have us just where they want us.
- Mr. Bracci stated that he was in a meeting this afternoon with Ms. Franzese and members of her staff. He commented that he was very impressed with what the Planning Department has done with the snowmobile clubs and their desire to promote snowmobiling in Delaware County.
 - Mr. Rowe commented on the amount of work the department handles with only a few

employees. He added the fact that there hasn't been a great turnover in the department is a credit to Ms. Franzese's leadership.

Mr. Donnelly remarked that Ms. Franzese is an example of doing more with less.

Chairman Eisel commented that snowmobiling provides a real economic benefit to our communities and gives our small businesses a shot in the arm.

Mr. Utter commented that his vote today indicated his support of the talented individuals working for the county. He stated, however, he is an advocate of a sliding scale for raises.
