REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

JULY 19, 2006

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, July 19, 2006 at 7:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present.

Mr. Donnelly offered the invocation.

Mr. Utter led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Commissioner of Social Services William Moon who introduced Kelly Ito as employee of the month.

Mrs. Ito joined the department in September 1999 as a Senior Account Clerk. She is the department's auditor and prepares all bills for the county audits. She operates the automated State payment system for accounts payable known as BICS and assists the accounting unit with a variety of other tasks.

Commissioner Moon said Mrs. Ito enjoys the variety of new experiences that come with the job, adding no two days are quite alike. Her work is always up-to-date and she is always available to help with a new program or function. She appreciates her co-workers and feels they are the best part of the office work. Mrs. Ito distinguishes herself in a quiet way each day at work and is a team player who regularly volunteers her services to other county departments when there is a need.

Commissioner Moon presented Mrs. Ito with a \$100.00 Savings Bond and thanked her for her dedication. Chairman Eisel presented her with the Certificate of Employee of the Month and thanked her for her dedicated service.

Chairman Eisel stated that catastrophic flooding from June 26 - 28 caused much devastation to the towns, villages and infrastructure of the county. At this time, estimates are between \$9 to \$10 million to replace seventeen bridges, three miles of road and ten miles of

shoulders. He pointed out that there are still four bridges from the November 2005 event that need to be replaced.

Chairman Eisel advised that he has been in touch with Governor George Pataki, Congressman John Sweeney, U.S. Senator Hillary Clinton, Senator John Bonacic and Assemblyman Clifford Crouch. Through their efforts, Delaware County has been declared a Category C by the President. He stated that our legislators have helped the county immensely, especially the State for picking up our share of the FEMA projects.

Chairman Eisel offered his thanks to all the people, county departments, DEP, DEC, the NYS National Guard, and the many organizations and volunteers that helped Delaware County get back on its feet. He stated he visited many towns and saw a remarkable recovery going on even though there is a great deal of work ahead of us. People are out there working and small businesses are beginning to open up again. He noted there are questions about whether some of the businesses will be able to make it and advised that we are still trying to get small business loans and grants for businesses and farmers.

Chairman Eisel granted privilege of the floor to Mr. Maddalone who introduced Director of Emergency Services (ES) Nelson Delameter. Mr. Maddalone stated he saw first hand what ES did for Sidney and added the entire county was covered very well by ES.

Chairman Eisel said he was at the command center several times and it was incredible to see ES and law enforcement people from all over the state coming together. The entire effort was well coordinated and Mr. Delameter and his team did an outstanding job. The response was tremendous. In his opinion, training for terrorist attacks and homeland security helped prepare the county to deal with this disaster.

Mr. Delameter provided a slide presentation of the devastation throughout the county. He advised the Emergency Operations Center (EOC) was mobilized on Tuesday, June 26th at 2:00 P.M. when all county and state agencies were brought in. The EOC was fully functional by that evening and ran 24 hours a day for approximately two weeks.

The official rain total from the National Weather Service in our area was 14.2 inches in a 24 hour period. At the height of the response there were over 250 volunteer and fire personnel from 13 counties. Mr. Delameter praised the immediate response from Delaware County's previous ES deputy, Glen Morrisson, currently employed by Jefferson County who called to offer his services. Mr. Morrisson ran the EOC as incident commander on the night shift for five or six days before he finally went home. In addition, there were emergency management personnel from Westchester County that were set up to assist in the EOC. The initial priorities were to meet the immediate needs of the people. Mr. Delameter stated that the EOC organized the first delivery of water and ice, adding this was done before any of the other organizations were established.

Mr. Delameter said that this was an overwhelming event that taxed the county and communities to the limit. There were things that could have been done better but, for the most part the response and meeting the needs of the people was done with great professionalism and timeliness.

Mr. Delameter in conjunction with other county departments, towns and villages estimate preliminary damages to public infrastructures and facilities at the present time to be \$75 million and climbing. He expects that figure to go much higher as information continues to come in. In addition, he expects private industries, businesses and residences could add another \$50 million. At this time, approximately 1,800 people have filed claims with FEMA. He complimented FEMA's efforts to get in touch with people. In contrast, the event in 1996 cost the county \$30 million. He said he has never seen anything like the magnitude of this disaster. Emotions and frustrations ran high but, everyone pulled together to get the job done.

Chairman Eisel granted privilege of the floor to Mr. Bachler who introduced Executive Director of Soil and Water District Conservation Rick Weidenbach and Stream Program Coordinator Scotty Gladstone. Mr. Bachler commented that the farmers were also hard hit by the flooding and noted the tremendous coordinated effort between Cornell Cooperative Extension, Watershed Agricultural Council, Natural Resources Conservation Service, USDA, Farm Service Agency NYCDEP and Delaware County Soil and Water Conservation District.

Mr. Weidenbach and Mr. Gladstone presented a slide presentation entitled Flood of 2006 Agricultural Emergency Response Team. Mr. Weidenbach thanked the Delaware County Conservation Partners which include Cornell Cooperative Extension, Watershed Agricultural Council, Natural Resources Conservation Service, USDA, Farm Service Agency NYCDEP and Delaware County Soil and Water Conservation District.

The mission of the Agricultural Emergency Response Team is to assess all programs in all watersheds for eligibility and funding. He explained that the response team is providing all the paperwork and the linkage between the farmer and the USDA agency in order to facilitate the receipt of benefits. Funding is available through programs such as: the USDA FSA Emergency Conservation Program, USDA FSA Crop Disaster Program, USDA FSA Livestock Compensation Program, USDA Emergency Watershed Protection Program, Watershed Agricultural Program and the Stream Corridor Management Program.

Mr. Weidenbach discussed the progress of the Agricultural Emergency Response Team, pointing out that 342 farms have been assessed to date, 94 received no damage, 70 were considered high priority, 107 considered medium priority and 71 considered low. The Emergency Conservation Program estimates that over 35 percent of the county's cropland was affected by the flooding. He noted this loss has the potential of creating a severe economic impact on the county. The team has completed 140 field assessments out of 248. The Emergency Watershed Protection Program found 280 sites where roads and bridges were impacted by the streams, Walton, Hamden and Hancock having the lion share of the affected

sites. He discussed the mission of the Stream Corridor Management Program, its progress and the immediate needs of the village and town of Walton as it relates to agriculture and infrastructure.

Mr. Homovich questioned how the farmers were going to address the feed loss problem. Mr. Weindenbach said the farmer will most likely sell off the cows they cannot feed or they will go out of business.

Cornell Cooperative Extension Senior Resource Educator Paul Cerosaletti commented that funding requests have been made to the USDA for programs that will help the farmers but, right now he suggested that farmers in need of feed contact the Cornell Cooperative.

Chairman Eisel asked if there are any hay surpluses around the state that our farmers could take advantage of. Mr. Cerosaletti said that North Carolina has offered to help out as well as farmers that did not sustain damage. In addition, a hay exchange has been set up on the internet.

Mr. Bachler questioned if USDA FSA Crop Disaster Program when funded was going to be able to help the farmers. Mr. Cerosaletti replied that the USDA programs provide funding to farmers who have sustained standing crop loss but, provides no coverage on harvested crop lost.

Chairman Eisel said in talking with Senator Clinton he learned that all the funding in that program was used to provide assistance after Katrina. He advised that Senator Clinton and Congressman Sweeney are working on funding the program.

Mr. Weidenbach remarked these programs are very much needed and expressed concern that funding wasn't readily available.

Chairman Eisel stated that our legislators hear us and are working to provide the funding that is needed. He asked that Mr. Weidenbach keep the Board advised as SWCD moves through the process of rehabilitating.

Chairman Eisel commented that on a tour in the town of Hancock with Commissioner of Public Works Wayne Reynolds he saw a bridge that received no damage but, the stream that ran under the bridge had moved 100 feet away from the bridge.

Mr. Rowe commented that funding will not be available soon enough for the town of Hancock to take advantage of. The town has already started repairing roads and will continue until they're done. He pointed out that the town saved \$1.4 million using gravel taken from gravel bars and private property. The town hopes to be back in business before the first day of school. He said every road north of Rte.17 was completely gone. Hancock had a real sense of urgency, there was no time to sit back and wait for funding. He thanked everyone for all the help he received.

Mr. Maddalone commented he was at the Sidney Civic Center and overheard an individual from one of the relief organizations say he has been to many places and has never seen the kind of cooperation that Delaware County provides. Mr. Maddalone said that statement speaks of the kind of people we have in Delaware County.

Mr. Maddalone said that Amphenol, a factory in Sidney, estimated approximately \$40 million in damages. They're making the necessary repairs and the factory is scheduled to open in the next few weeks.

Mr. Meredith said that Walton had 66 roads wiped out. Within a few days with the help of the NYS National Guard and the County Department of Public Works crew most roads were passable. He reported ditches eight to ten feet deep. He thanked everyone for their help and support.

Mr. DuMond stated that the town of Masonville did not suffer the extent of damage many of the other towns in the county did. At the height of the impact Masonville lost their fire department ambulance. He contacted ES and in a very short time another ambulance was sitting in the driveway. He added it was remarkable and extended his thanks to Mr. Delameter and all the volunteers at the EOC. He said the town of Masonville is now helping the towns of Sidney and Tompkins.

Mr. Utter said the town of Middletown faired well in comparison to many of the towns. He offered his thanks to all the volunteers and commented that the county had a chance to see how smooth the EOC can operate when the going gets tough. He complimented the contributions of Delaware County personnel and volunteers who gave so much of their own time, adding he is proud to be a part of this county.

Mr. Donnelly remarked that Main Street, Andes saw five feet of water in some places. Homes along Main Street flooded and the fire department worked long hours pumping basements. Several back roads were washed out and there is a great deal of work to be done but, Andes didn't see near what some of the other towns experienced. He advised that he received a call from Deputy Director of the NYC Bureau of Water Supply Ira Stern asking what they could do to help. He said NYCDEP stepped up to the plate and within hours help came. He felt there was hope for improved relationships.

Mr. Valente stated that Davenport did not get hit as bad as some towns. He said it was remarkable with everything that was going on that he received calls from the EOC offering help. He said the Department of Public Health advised why people were getting sick and began distributing information advising people what to do in a flood situation. He also thanked the Department of Public Works and Solid Waste Management for enabling the removal of all the C&D material and saving him the chore of figuring out how to get dumpsters. People worked around the clock to get things done and he expressed his appreciation to everyone.

Mr. Marshfield said Hamden saw a couple of million dollars worth of damage on the roads. He told of an experience while working for his employer the Delaware County Electric Cooperative. The Cooperative was called to restore power to residents on Platner Brook Road. When the repair crew arrived they found Platner Brook flooded and realized they would be unable to make any repairs until the water was diverted. Mr. Marshfield said as he was assessing the situation he saw crews from DPW already at work diverting the water. Power was restored to the residents in a few days because of the quick response from DPW. He also thanked the many local contractors and organizations for their assistance.

He also told of a distress call he received from the Walton School advising that they were out of food. He and his wife responded to the call and set out to purchase food from local establishments. He was impressed with the generosity of store managers and in particular a traveler from Maryland, New York who upon hearing of the situation donated \$191 and the services of his contracting firm if needed.

Mr. Woodford commented on the spirit of cooperation between the village, town and county. He advised that the town of Deposit lost their highway garage, judges chambers and town clerk offices. He expressed his thanks to everyone who helped in anyway, adding that many of these people had their own personal flood related problems and still reached out to do what they could for others. He really appreciated how everyone pulled together.

Mr. Maddalone said that for an entire week the New York City Department of Sanitation was taking care of all the garbage in the town of Sidney and they did a fantastic job.

Mr. Homovich also expressed his thanks to everyone and commented on the amount of cooperation and help. He said this is a great county and a great place to live. He complimented the workers from the NYCDEP, adding they worked all day long and were a great group of guys. He said that he was so impressed with the men that helped Colchester that when they were leaving he and his wife thanked them and invited them back.

Mr. Bachler said that the crews from New York City really made an effort to be nice. He commented that they were friendly and he believed they felt they were welcome.

Mr. Donnelly stated that out of tragedy comes good. He relayed a story from Mayor Snow of Walton who said the residents of the village were standing in awe as New York City trucks came through the village cleaning the roads.

Mr. Shelton commented that maybe New York City is finding out that they can catch more flies with sugar than vinegar.

Chairman Eisel stated that New York City did step up to the plate and really did a lot to help us out.

Mr. Utter remarked that he hated to throw cold water on a hot party but, said we should not drop our guard with the NYCDEP. He referenced the 1996 event and said New York City also stepped up to the plate. He reminded the Board to look at what has been going on since 1996, adding the people who have their feet on the ground are humans just like us, it's the people upstairs we have to be careful of.

Mr. Rowe thanked the EOC in Delhi and said the EOC was able to arrange for clearance for the town of Hancock to mobilize their trucks. He added it wouldn't have been possible without them. He also expressed his thanks to everyone who in anyway provided assistance. Everyone did what they thought was right at the time and it all got done, adding it was phenomenal what was done.

Chairman Eisel again complimented everyone and advised that he is working on putting together a list of everyone who made donations.

Mr. Maddalone offered the following resolution and moved its adoption:

RESOLUTION NO. 162

TITLE: APPRECIATION OF ASSISTANCE DURING THE FLOOD OF 2006

WHEREAS, from June 26 - 28, 2006, Delaware County experienced widespread catastrophic flooding, adversely affecting many of its towns and villages, warranting the declaration of a countywide "State of Emergency"; and

WHEREAS, the severity of the storm damage resulted in loss of homes, businesses, and lives as well as extensive damage to roads, bridges, and infrastructures throughout the county; and

WHEREAS, assistance was immediately forthcoming from the Sheriffs' Offices of Cattaraugus, Cayuga, Jefferson, Onondaga, Putnam, Schuyler, Sullivan Tompkins, Yates, Warren, and Westchester counties, emergency management personnel from Dutchess, Jefferson, and Westchester counties, fire and emergency medical services workers from Columbia, Dutchess, Erie, Franklin, Genessee, Greene, Onondaga, Rensselaer, Saratoga, Schenectady, Senaca, Suffolk and St. Lawrence counties, personnel from the NYC Department of Sanitation, the State University of Delhi, the NYS National Guard, the American Red Cross, the Salvation Army, the United Way, various organizations and businesses, and the countless volunteers too numerous to mention

THEREFORE, BE IT RESOLVED that the citizens of Delaware County and the Delaware County Board of Supervisors publicly acknowledge with gratitude and appreciation the personal sacrifice and humanitarian efforts expended by all who administered to Delaware

County's needs and worked long and hard to assist the county in this time of emergency.

The resolution was seconded by Mr. DuMond.

Mr. Bracci commented that SUNY Delhi was a host site and that emergency service vehicles filled two parking lots.

The resolution was unanimously adopted.

Mr. Utter offered the following resolution and moved its adoption:

RESOLUTION NO. 163

TITLE: SUPPORT FOR ACQUIRING UNITED STATES DEPARTMENT OF AGRICULTURE FUNDS TO REPAIR DAMAGED LOCAL INFRASTRUCTURE AND ASSISTANCE TO DELAWARE COUNTY FARMERS DEPARTMENT OF WATERSHED AFFAIRS

WHEREAS, the June 27-28, 2006 flood caused severe damage to local infrastructure and severe harm to agriculture producers; and

WHEREAS, the cost to repair this devastating damage is overwhelming and beyond the fiscal capability at the local municipal or farm level to repair; and

WHEREAS, agriculture is a critical economic force in Delaware County; and

WHEREAS, assessments of the cost of damages to agriculture continues; and

WHEREAS, infrastructure damage to town roads in Delaware County is creating severe risks to public safety and negatively impacting local commerce; and

WHEREAS, the estimate of damages to town roads eligible for USDA Emergency Watershed Protection program funds is \$25 million; and

WHEREAS, the Delaware County Board of Supervisors applauds the recent efforts and announcements made by members of our Congressional delegation.

NOW, THEREFORE BE IT RESOLVED, that the Delaware County Board of Supervisors requests that our Congressional delegation continue to vigorously solicit Congress to acquire the necessary USDA funds to make our local infrastructure and farm community whole.

BE IT FURTHER RESOLVED, this resolution be forwarded to our Congressional delegation.

The resolution was seconded by Mr. Bachler and unanimously adopted.

RESOLUTION NO. 169

TITLE: APPROPRIATION OF SURPLUS SOLID WASTE CAPITAL

WHEREAS, the damages caused by the recent flood have created an enormous amount of Municipal Solid Waste (MSW) and Construction and Demolition material (C&D); and

WHEREAS, the Solid Waste Management Plan and long range goals of the Solid Waste Management Center are unable to accommodate the increased volume of material, causing the Department to have to hire trucks to haul this waste to other facilities for disposal.

NOW, THEREFORE, BE IT RESOLVED, that following appropriation of surplus be made to cover the unexpected expense of hauling and disposing of this material.

The resolution was seconded by Mr. Woodford.

In answer to Chairman Eisel, Mr. Utter explained the fee to dump C&D was waived for the victims of the flood. Originally, the facility was going to accept all the C&D however, once the magnitude of the flood was realized it was determined if the facility accepted all the C&D it would be full. On a normal day, the facility receives 100 tons of C&D material. Since the flood, it has increased to 300 tons a day. As a result the decision was made to dispose of the excess 200 tons a day by sending it out of county. The cost of disposal to date is \$520,000. The decision was based on the need to save airspace in the landfill, and that the expense incurred as a result of the flood is reimbursable by FEMA.

Mr. Utter advised that the tipping fee will be reinstated on July 29th. After that time, if anyone has any eligible flood related debris they should contact their town Supervisor to have the fee waived. He referenced the handout on each of Supervisor's desk detailing the tipping fee schedule.

Chairman Eisel stated that this was an excellent move because if we filled the landfill it would be a direct cost to the county of approximately \$1 million an acre.
