REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

AUGUST 23, 2006

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, August 23, 2006 at 7:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present except Ms. Molé.

Mr. Donnelly offered the invocation.

Mr. Hynes led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Director of Public Health Bonnie Hamilton who introduced Dawn Pierce as employee of the month.

Ms. Pierce was hired as an Account Clerk Typist in April 2001, promoted to Senior Account Clerk January 2002 and promoted to Children's Program Specialist January 2006. WHEREAS, the flooding of June 27 and 28 of 2006 severely damaged a portion of County Route 67 in the Town of Hancock; and

WHEREAS, to repair the damaged roadbed and restore the stream bed in a manner that mitigates the possibility of future damage from flooding necessitates a change in alignment of the County road; and

WHEREAS, the shift in alignment requires additional right-of-way; and

WHEREAS, the landowners are willing to deed the required right of way to the County of Delaware in exchange for a piece of adjoining County right-of-way which is no longer needed for highway purposes.

NOW, THEREFORE, BE IT RESOLVED that the Delaware County Department of Public Works is authorized to acquire the required right-of-way from James Crawford and George D. Crawford in exchange for the adjoining right-of-way which is no longer needed for highway purposes; and

BE IT FURTHER RESOLVED that the County of Delaware is authorized to convey the unused portion of the existing right of way to James Crawford and George D. Crawford.

Mr. Utter said that an additional right-of-way was needed to help repair a roadbed and explained that the Crawford's were willing to deed the required right-of-way to the county in exchange for a piece of adjoining county right-ofway which had become worthless to the county.

WHEREAS, Delaware County and the municipalities therein have identified a history of damages resulting from flooding, severe storms, winter storms, and other weather-related phenomena, and have recognized the potential for future damages resulting from natural, human-caused, and technological disasters; and

WHEREAS, an All-Hazards Mitigation Plan can provide recommendations to help prevent and minimize the damages resulting from such events; and

WHEREAS, the adoption of an All-Hazards Mitigation Plan is required to be eligible to receive State and Federal funding for hazard mitigation initiatives; and

WHEREAS, the Delaware County Board of Supervisors determined in Resolution No. 107 of 2003 that a multi-jurisdictional All-Hazards Mitigation Plan representing all the towns and villages in Delaware County would be more efficient to produce than each community drafting and adopting their own; and

WHEREAS, the Delaware County All-Hazards Steering Committee was formed to oversee preparation and adoption of the Plan in concert with the project consultant selected through an RFP process, Tetra Tech EMI; and

WHEREAS, the involved municipalities subsequently drafted the Plan in accordance with the requirements of the New York State Emergency Management Office (SEMO), the Federal Emergency Management Agency (FEMA), and Disaster Mitigation Act of 2000; and

WHEREAS, the Plan includes jurisdiction-specific recommendations to minimize the damages associated with natural, human-caused, and

technological disasters; and

WHEREAS, the Plan has been made available for the public review online at the Delaware County Planning Department Hazard Mitigation website (http://www.co.delaware.ny.us/depts/pln/HazardMitigation.htm) and by placement in municipal offices, the Delaware County Planning office, and local libraries, with notices published in five local newspapers, inviting public comment; and

WHEREAS, public meetings were hosted by the Steering Committee throughout the development of the Plan to discuss the contents of the Plan with members of the public; and

WHEREAS, comments from the public and Steering Committee have been incorporated into the Plan; and

WHEREAS, the revised Plan is wholly supported by its viewers; and

WHEREAS, Delaware County has reviewed the Plan and affirms that the Plan will be updated no less that every five years; and

WHEREAS, the adoption of the Delaware County All-Hazards Mitigation Plan by municipalities is a Type II Action under State Environment Quality Review Act and will not result in a significant adverse environmental impact;

NOW THEREFORE, BE IT RESOLVED, Delaware County adopts the Delaware County Multi-Jurisdictional All-Hazards Mitigation Plan as its All-Hazards Mitigation Plan and resolves to execute the actions in the Plan.

LOCAL LAW N0. 23 2006

AMENDING LOCAL LAW NO. 1 OF 2005 TO MAKE TECHNICAL CORRECTIONS TO THE EMPIRE ZONE BOUNDARIES

WHEREAS, on September 28, 2005, in accordance with the applicable provisions of law, the Delaware County Board of Supervisors approved Local Law #1 of 2005 authorizing the County of Delaware to submit an application for designation of certain areas within Delaware County as an Empire Zone; and

WHEREAS, Schedule A, of Local Law No.1 of 2005 set forth the boundaries of said areas; and

WHEREAS, in order to comply with the Legislative intent and legal requirements of the Empire Zone Program, Delaware County is now required to make technical corrections to the boundaries of said areas.

NOW, THEREFORE, BE IT enacted by the board of supervisors of the county of Delaware, as follows:

Section 1. Schedule A, of Local Law #1 of 2005 is repealed.

Section 2. The Schedule A attached hereto and made a part hereof shall be substituted for the original Schedule A.

Section 3. This local law shall take effect upon filling in the Office of the Secretary of State as provided by Section 27 of the Municipal Home Rule Law.

LOCAL LAW INTRO. NO. 24 OF 2006

DELAWARE COUNTY REAL PROPERTY TAX INFORMATION

Be it enacted by the Board of Supervisors of the County of Delaware as follows:

I. DEFINITIONS:

- 1. RPTS shall mean the Delaware County Real Property Tax Service.
- 2. ORPS shall mean the New York State Office of Real Property Services.

II. SERVICES TO BE PROVIDED TO THE TOWNS BY RPTS.

- 1. Data Input including:
 - A. 5217 sale transfers
 - B. Name and address changes
 - C. Data entry input (new, changes & deletions, etc.) for assessments, exemptions, etc
- 2. Maintenance of RPTS library including:
 - A. Swiss code, school codes, exemption availability
 - B. Bank Code reference tables
 - C. Exemption amounts (t/c/s)
 - D. Next year processing
 - E. Star exemption reference table
 - F. Veterans exemptions reference table
- 3. Processing of rolls/bills including printing for:
 - A. Tentative tax roll
 - B. Final roll
 - C. Town/County tax bills (& rolls)
- 4. Processing and preparation of Assessors Report to ORPS
- 5. Submission of Sales Transmittals to ORPS
- 6. Transmission of Rolls to ORPS
- 7. Balancing and reconciling necessary reports

III. SERVICES TO BE PROVIDED BY THE TOWN TO

- 1. Submission of all assessment changes, names and address changes, and exemption changes.
- 2. Towns must use as directed by RPTS database, database level, build number, database processing year.
- 3. Towns must submit all required data within specified time period
 - A. April 5th of each year (for production of Tentative Rolls)
 - B. June 14th of each year (for production of Final Rolls)
 - C. August 1st of each year (for production of School Tax Bills)
 - D. November 15th of each year (for production of Town/County Tax Bills)
- 4. The Town may elect to provide such information more frequently than the dates set forth above.
- 5. All changes sent to RPTS must be on approved forms before submission and acceptance by RPTS.

IV. ADDITIONAL PROVISIONS

RPTS

- 1. The County must be the main file for all tax rolls and bills.
- 2. Upon request, the County will provide a central database to Town assessors monthly.
- 3. The Town will pay all licensing fees for use of the Real Property Tax Service program.
- 4. Chargebacks to the Town by the County will remain the same, in other words, the Town will be charged for the cost of production of tax rolls and bills and additional supplies to the Town assessors.

5. If the data is not timely submitted, a previous file will be used for production of rolls and bills and the Town will assume all responsibility for any inaccuracies, omissions and any errors in tax bills resulting from the Town's failure to provide required information.

V. PENALTY

- 1. Should the Town violate any of the provisions of this agreement, the County will withhold the payment of the Town's share of mortgage taxes collected.
- 2. Should the Town fail to provide pursuant to paragraph III (3), the information required within ten (10) days of the due date of said information, the County will withhold from the annual distribution of mortgage tax reimbursement to the Town 20% of the mortgage tax reimbursement; if the information is not provided within 20 days, the County will withhold 50% of the mortgage tax reimbursement; if the information is not provided within 30 days, the County will withhold 100% of the mortgage tax reimbursement.
- 3. The penalty called for in paragraph V(2) shall be computed by reducing a Town's annual mortgage tax reimbursement for the calendar year in which such violation occurs. Should the Town have already received a portion of its mortgage tax reimbursement for the calendar year and the total of said penalty can not be recovered from the remaining amount due for that calendar year, the penalty shall be deducted from the next year's mortgage tax reimbursement.
- 4. Should the penalty provisions of paragraph V(2) become effective, a Town at its request shall be entitled to a hearing on the issue of the penalty. The hearing officer shall be the County Real Property Tax Director.
- 5. For the reason for such delay is due to forces beyond the control of the Town, there should be no reduction in mortgage tax reimbursement.

VI. EFFECTIVE DATE

1. This Local Law shall take effect immediately.

The local law was seconded by Mr. Marshfield and Mr. Rowe.

Mr. Donnelly offered the following resolution and moved its adoption:

TITLE: PUBLIC HEARING ON LOCAL LAW INTRO. NO. 24 OF 2006 REAL PROPERTY TAX SERVICE DEPARTMENT

WHEREAS, Intro. to Local Law No. 24 of 2006 establishes the responsibility between the County and the Towns for the maintenance of real property tax information

NOW, THEREFORE BE IT RESOLVED, that a public hearing be held on Local Law Intro. No. 24 on September 13, 2006 at 6:45 P.M. in the Supervisor's Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York.

The resolution was seconded by Mr. Marshfield and unanimously adopted.

Mr. Marshfield requested that Chairman of the Public Works Committee Mr. Utter provide an update every six months or sooner composting facility.

In answer to Mr. Marshfield, Mr. Utter stated that everything is going as planned. He said according to Director of Solid Management Sue McIntyre, the facility is providing a good product. He pointed out the product has been sent out for testing and that to date none of the product has been sold. There are a few bugs that are still being worked out but, by and large it is going as planned.

Mr. Utter stated in response to Mr. Marshfield that the maturation chamber does have product in it.

Mr. Bachler commented that there has already been requests for product.

Mr. Utter advised that Ms. McIntyre said at this time the product is not to be used as topsoil by itself, it has to be mixed in with other soil. The reason for this is that the product is not completely aged, adding it takes the product about a year or two to age completely. Mr. Meredith asked what percentage of Municipal Solid Waste (MSW) is going into compost at this time. Commissioner Reynolds answered about 80%, adding the remainder is sent to the landfill and buried.

Commissioner Reynolds commented that the flood has stirred the percentage up some. He pointed out that 80% of what comes into the facility gets sent to composting. He pointed out that the facility is very close to meeting the bypass of about 70 percent of what goes into the compost comes out as soil amendment.

Mr. Marshfield asked if some of the leachate is being used in the digester. Commissioner Reynolds explained that at this point no, a quality record needs to be established based on what is coming in the front door before we start adding the leachate as a moisture additive.

Upon a motion the meeting was adjourned for a short recess and reconvened with all Supervisors present except Ms. Molé.

Chairman Eisel waived Board Rule 10 to permit the introduction without objection of the following not pre-filed resolutions.
