REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

JANUARY 24, 2007

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, January 24, 2007 at 1:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present.

Mr. Donnelly offered the invocation.

Mr. Woodford led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted with the following correction to page five. Mr. Marshfield noted that his vote against the resolution presented by the Hamden Town Board is a separate issue from his belief that the County Planning Department acted strictly as an advisor to the town of Hamden.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Director of Emergency Services Nelson Delameter who along with 911 Coordinator Steve Finch presented a powerpoint presentation entitled 9-1-1 Past, Present, Future.

Mr. Delameter referenced many of the technological advances that are causing the county to take a serious look at changing the way the county provides 911 emergency services. Currently, our Public Safety Answering Point (PSAP) is at the State Police Troop C Barracks located in Sidney and the administration is located at the Public Safety Building in Delhi, approximately 40 miles apart in distance. The Public Safety Committee and the departments responsible for public safety feel the residents of this county would be better served with the PSAP operated by the county at the Public Safety Building.

Mr. Delameter introduced 911 Coordinator Steve Finch whose presentation briefly discussed the history of emergency services operation pre-911, the current 911 operations and a look at the needs of our county in the future.

Mr. Finch stated in February of 2002 emergency service personnel agreed that 911 was essential for public safety. Committees were formed and policies and procedures were written. At that time, the Sheriff's administration lacked the facility, the staff and finances to

accommodate a 911 center. The New York State Police (NYSP) stepped up and offered their facility, their staff and their services making 911 a reality for Delaware County. Delaware County was the first and only county in New York State to have the county 911 system housed and operated exclusively by the NYSP. Mr. Finch acknowledged with appreciation the job the NYSP has done in handling the county's 911 center. In 2006, the PSAP responded to 17,353 911 emergency calls.

Mr. Finch noted a few of the difficulties he experiences supervising and administrating the PSAP in its current configuration and pointed out that along with growth and development comes issues such as, training, staff shift logistics, and new policy implementation. The future of 911 includes internet protocol based on ability to accept streaming video, text messaging, digital photos, onboard vehicle emergency warning system and reverse 911 emergency notification which will require onsite hands on administration.

The NYSP agree that the 911 system is a function of the county and should be administrated by the county. Deputy Superintendent Technology and Planning Colonel Steve F. Cumoletti and Troop Commander Major Kevin Molinari of Troop C, as well as Division Communications staff have committed to meet the PSAP obligations under the current terms while the county makes its evaluation.

In addition to the current county communications staff, it is estimated that the county would need an additional six full time dispatchers to operate the program. Currently, there is a 911 reserve fund and additional revenue could be raised from the enactment of a wireless 911 surcharge of .30¢ per cell phone.

In conclusion, Mr. Finch pointed out that the departments responsible for ensuring an efficient, effective, and progressive public safety program, the Delaware County Emergency Services, the Sheriff's Department, the Department of Public Health and the Department of Public Works, feel strongly that transferring the 911 center to the Public Safety Facility is in the best interest and is essential to the public safety of our county residents.

In answer to Chairman Eisel, Mr. Finch replied that during the transition period, the NYSP would be the county's back up if the transfer to the Public Safety facility were to take place. Perhaps Otsego county would become our back-up site and if not, another site would be sought.

In reply to Mr. Bracci, Mr. Finch stated that the proposed .30¢ cell phone surcharge would apply only to phones issued in Delaware County. Mr. Delameter pointed out that the billing address is used to determine which county would receive the .30¢ surcharge. Mr. Finch explained that counties currently have a hardline surcharge but, are looking at enacting a wireless surcharge as they are seeing a drastic drop in their hardline surcharge revenue as wireless ability improves.

In answer to Mr. Bracci, Mr. Finch stated that between the revenue from the hardline surcharge and the proposed cell phone surcharge it is felt that two of six full time positions could be offset.

Mr. Homovich commented that years ago he was opposed to shipping the 911 service to the NYSP, adding that he felt the county had a good system under the Sheriff's Office. He expressed concern that the cost of running a 911 facility at the Public Safety Building might be a budget buster and he would like more information before he makes any decisions.

Mr. Maddalone said the primary reason for 911 was to create one three digit number that could be dialed by everyone to get help. He referenced Sidney's old system and stated that he felt it worked great until the people chosen to man the phones no longer wanted to do it. He felt that the county has the perfect solution to the problem by relocating the facility to Delhi and having the county run it.

Mr. Marshfield commented that many of the complaints he heard from the public were received upon start up. He stated he hasn't heard a complaint from the public in years and that, in his opinion, should say something about the job the NYSP are doing. He expressed concern over the fact that the Board is discussing hiring six additional full time people to man a county operated 911 facility while striving to cut county government.

Mr. Maddalone said that the Public Safety Committee receives and addresses 911 concerns regularly, adding in his opinion, having the 911 facility in Delhi would provide better emergency service to the county.

Mr. DuMond stated as a member of the Public Safety Committee he strongly supports this initiative. He thanked the NYSP for stepping up to the plate and pointed out that without them public safety would have definitely been compromised. In his opinion, 911 is a county function, the appropriate thing to do is have the county handle this service with county employees.

Mr. Bachler remarked that he didn't think it was fair to blame the previous Sheriff Office for not wanting the PSAP center at the old jail. In his opinion, the Supervisors should accept part of the blame. He noted that he was on the Public Safety Committee at the time and it was the feeling of the Committee that budgets were tight and we were concerned about the budget. He said things have changed, there is more money now.

Mr. Utter thanked the NYSP for bringing Delaware County into the 21st century and for the job they are doing for us. He cited a recent problem in Middletown involving mutual aid and a misunderstanding of the tower operation, adding it was quite a mix up. In his opinion, the public safety of our residents is the number one concern.

Mr. Valente commented that he supports the 911 program but would like to see the .30¢

cell phone surcharge enacted first.

Mr. Bracci stated that he believes it is absolutely essential to have a 911 function in this county and pointed out that we are the only county in the State of New York that is relying on the State Police for the safety of our residents.

Chairman Eisel thanked the NYSP for doing an outstanding job and asked that no criticism be taken from today's comments. He said the NYSP stepped up to the plate and deferred a very large expense for Delaware County.

Chairman Eisel referred the matter to the Budget Oversight and Finance Committees for review as this is a new program not in the budget for 2007 at a cost of approximately a quarter of a million dollars.

Mr. Ryan remarked that if the employees are hired by the Sheriff's Office than Mr. Finch should be under the Sheriff's Office to oversee the PSAP in order to avoid bureaucratic problems.

Chairman Eisel granted privilege of the floor to Mr. Utter who introduced Executive Director of Soil and Water Conservation District (SWCD) Richard Weidenbach.

Mr. Weidenbach, explained that the United States Department of Agriculture Natural Resources Conservation Service (NRCS) is one of several federal departments that work in partnership with the SWCD. In addition to providing technical information the NRCS brings federal dollars to the county through the Emergency Watershed Protection Program (EWP).

In 1986 the EWP brought in \$1.5 million and in 1996, \$3.5 million in emergency disaster funding. In June 2006 the county estimated a need of \$25 million, but as a result of federal disasters the program was unable to provide funding at that time. The opportunity became available on January 16th when NRCS advised SWCD that \$11 million of disaster funds had become available. Because the work must be completed in 220 days the towns and county will need to act quickly. Mr. Weidenbach commented that he invited the Town Highway Supervisors to hear the presentation and arranged for a question and answer period after the presentation.

Mr. Weidenbach introduced USDA State Conservation Engineer of NRCS Peter Wright and Mike Clifford who provided an overview of EWP and the opportunity that it presents for Delaware County.

Mr. Wright said that \$11 million dollars of emergency disaster funding is available for Delaware County. He stated EWP's purpose is to restore the Watershed to a stable condition by responding to natural disasters and by relieving the threat of imminent hazards to life and property caused by flooding and erosion. NRCS requires that all projects must be sponsored by a local unit of government.

The presentation detailed the expenses that are eligible and those which are not as well as the emergency work time line, cost share, sponsor responsibilities and the typical process that NRCS requires.

In answer to Mr. Homovich, Mr. Wright confirmed that the town would be required to pay its 25% share up front.

Mr. Weidenbach said that if the towns and county are interested and want to proceed, the first concern should be to identify their sites. SWCD will go to the sites to perform the damage survey reports and if it is determined that the work cannot be completed in the 220 days a request for extension will be made to the NYCDEC Commissioner for permit relief. He noted that the current extension expired on December 31, 2006.

Chairman Eisel asked if it was realistic to think that the work could be completed in the 220 day time frame. Mr. Wright said it would be a challenge. There is the possibility of an extension but, he felt that the towns and county should enter the program with the same sense of urgency experienced in June.

In answer to Chairman Eisel, Mr. Wright said that NRCS must conform to all laws and therefore, would not be able to supersede the NYCDEC permitting process.

In reply to Mr. Valente, Mr. Wright explained that in-kind services could be many things, among them labor, materials and equipment. Mr. Wiedenbach noted that in 1996 with in-kind services and additional federal funding the towns outlay was a wash.

Mr. Shelton said that the town of Tompkins has \$1.5 million worth of damage from the June flood and questioned when the towns would have the time to put their people to work on these jobs. Mr. Wiedenbach acknowledged the difficulties but felt that the NRCS has put an opportunity before us, the towns could either accept it or let it go.

In reply to Mr. Marshfield, Mr. Wiedenbach said the sponsors will determine the priority list of the projects. Mr. Wright said that the final decisions will be made by the NRCS.

In answer to Mr. Ryan, Mr. Wiedenbach stated that Mike Clifton and Peter Wright are the contact persons and SWCD will be assisting in the program.

Mr. Marshfield asked if one town elects not to sponsor a project can another town sponsor the project in the adjourning town. Mr. Wright said only if the town could guarantee the land rights.

Chairman Eisel asked Department of Public Works Commissioner Wayne Reynolds if the county had any infrastructure at risk. Commissioner Reynolds said that the county is finishing up its work with FEMA. There are a few jobs still out there that have some questions as to whether

FEMA is going to accept them.

Mr. Rowe commented on the similarities between FEMA's eligibility and ineligibility lists. He said that in many cases the emergency work needs to done even before there is an opportunity to apply for funding. He pointed out that the town of Hancock is \$8 million in debt from the last flood.

In reply to Mr. Valente, Mr. Wiedenbach said that he will be working with the Highway Superintendents of each town. If he doesn't hear from a town he will assume that town is not interested.

In response to Mr. Homovich, Mr. Wiedenbach said that engineers will assist SWCD with the damage survey reports. Mr. Wright said that once the cost estimates and sponsors are in place a town could make a request for an engineer if one was needed.

Mr. Wiedenbach said the first step in his opinion is to go out and make an assessment to determine if there is a need.

Mr. Marshfield commented that some projects may be out of the scope of the Town Highway Superintendent and therefore would not be considered as a job that might be eligible. He cited stream erosion problems that may affect the community but, not a town highway.

In response to Mr. Hynes, Mr. Wright said that once the job is complete and the federal form is submitted, a town could expect a reimbursement check within fourteen days.

For Standing Committee Reports, Budget Director John Meredith pointed out that an error of \$243,000 was discovered between the interfund transfers of the General and Road Funds. The State Comptroller's Office was consulted and a correction will be done at the end of the year. The adjustment will not impact the tax levy. He apologized for the clerical error and oversight. He stated he will be changing the format of the budget to prevent this from happening again.

For Standing Committee Reports, Mr. Homovich stated that on January 18th the New York State Blue Stone Industry met with the New York City Department of Environmental Protection (NYCDEP). In his opinion, it was a very good meeting with a good exchange about the blue stone business. He felt there is a good possibility that some of their land would be opened up for quarrying. Within a few weeks, the NYCDEP representative will be coming back to look at some of the quarries. He felt that this a first step toward creating a pilot program.

Chairman Eisel announced that the Delaware River Basin Committee (DRBC) will be coming to Delaware County for a public meeting and presentation on February 8, 2007 at 6:30 P.M. in the Board of Supervisors' room. He encouraged the Supervisors to attend and tell their stories. The DRBC's temporary release program is working and it is our desire that they will

adopt this program at their annual meeting in May of 2007.

Chairman Eisel announced that all Standing Committees will remain the same and that on each Supervisors' desk is the 2007 Supervisor's card reflecting the committee assignments.

Mr. Maddalone offered the following resolution and moved its adoption:

WHEREAS, the New York State Division of Criminal Justice Services, under the guidelines of the State Homeland Security Program, has announced the availability of a grant which will subsidize 100 percent of the cost of purchasing in-car/transportable video camera systems for our road patrol vehicles; and

WHEREAS, application for this grant has been made and when awarded, the county will receive a grant in the amount of \$19,600.00; and

WHEREAS, this grant will accomplish the installation of video cameras in our patrol vehicles, for the purpose of transmitting data and images for comparison with state records, suspect files etc.; and

WHEREAS, this grant will also accomplish the installation of video cameras in our vehicles, which practice is widely utilized for providing an accurate, unbiased accounting of events that have transpired during routine traffic stops, and other miscellaneous law enforcement investigations.

THEREFORE, BE IT RESOLVED that the Sheriff's Office be authorized to accept the grant funding as described above and that the 2007 budget be amended to established the following accounts:
