REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

OCTOBER 24, 2007

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, October 24, 2007 at 1:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present except Mr. Hynes.

Mr. Donnelly offered the invocation.

Mr. Valente led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel noted that County Clerk Sharon O'Dell was attending a meeting in Cortland, New York regarding Governor Spitzer's proposal to give driver's licenses to illegal immigrants. A petition prepared by Mrs. O'Dell in opposition to the Governor's proposal was passed to each Supervisor for their signature. The petitions will also be posted in County buildings for anyone desiring to sign. Chairman Eisel remarked that Mrs. O'Dell is doing all she can to stop the Governor's proposal.

Chairman Eisel granted privilege of the floor to Agriculture and Natural Resources Committee Chairman Frank Bachler. Mr. Bachler noted that the presentation given today is very special to him as it is honoring agriculture and farmers, especially the young farmers. He asked that Clerk of the Board Christa Schafer read Resolution No. 230 entitled Support for Agriculture and Farm Families at the conclusion of the presentation. He thanked the farmers for taking time from their day to attend the meeting.

Mr. Bachler introduced Cornell Cooperative Extension Agricultural Program Leader Mariane Kiraly and Amy Kenynon, who serves on the Board of Farm Catskills.

Ms. Kenyon explained that Farm Catskills is a non-profit organization based in Delaware County that is dedicated to preserving and promoting agriculture in the region. The organization works to support the families who work the land as well as protecting the land itself.

There are about 700 farmers in Delaware County. Although farming is considered a risky venture, it is relatively stable in Delaware County and continues to generates about \$50 million in sales annually. Agriculture has the highest "multiplier effect," meaning the money

turns around in the county more than any other type of business. Agriculture generates more income than tourism, home building or retail sales for the county.

Ms. Kenyon asked the Board to provide funding for an economic development specialist devoted to agriculture. She explained that according to the Department of Agriculture and Markets, the counties that have made this investment have had the greatest success in implementing their Farmland Protection Plan and developing new agricultural development. A great deal of investment and time goes into economic development to encourage small business growth. There are more than 40 full-time farmers under the age of 40 in Delaware County. This is an indication that many families want to invest and build their farming business in the County.

She pointed out that Farm Catskills is researching a tool being used in other states called "affordability easement." The basic concept is the New York City Department of Environmental Protection needs to make farmland affordable for farmers to purchase, rather than taking it out of agriculture. Farm Catskills is asking New York City to put \$10 million into a pilot program from the \$300 million they plan to spend in the region buying land and easements.

New York State has made funding available for each town to develop its own farmland protection plan. These funds will allow a town to go into much more detail about what land should be protected for farming and what land should be available for commercial or residential development. Adopting these plans at a town level could give each town more leverage with the City and State.

Ms. Kenyon stated agriculture is alive and well and can continue to be far into the future. She thanked the Board for their continued support.

Mrs. Kiraly explained her involvement with farm families is to help them with paperwork and lease agreements and be available if they require help with other issues. She talked about farmers under the age of 35 and the difficulty they face in pursuit of their agricultural endeavor. Many of the young farmers have to secure loans and rent a facility to farm. For most, this requires a lengthy process usually with the federal government or with a local bank for a federal guaranteed loan as farm loans are considered risky.

Much of the products produced on Delaware County farms are sold outside the county but, the money the farmers earn is most often spent inside the county, generally on products purchased to facilitate the farm. She pointed out that when the farmers prosper, so do support industries such as feed companies, seed suppliers, veterinarians and other businesses that support agriculture.

Mrs. Kiraly introduced the farmers in attendance by town and offered a summary of their farming contributions to Delaware County. She also introduced Agricultural Teacher and Future Farmers of America (FFA) advisor Mike Cipperly. Mr. Cipperly stated that there are fifty-five students in the agricultural program and the seven students in attendance are the ones who are seriously considering farming as their occupation.

Jacob Burgin, who farms on a multi-generation farm in Fraser, referenced a statement from a book entitled *The Rest of The Story about Agriculture Today* by Dr. Harold Willis, supporting the point that farming is an economically positive business. The book points out that the gross income earned by farmers for their raw commodities when spent by them generates about seven dollars of income in the economy for each dollar spent and this seven to one ratio has held true since 1921.

Mr. Utter remarked that farming is one of the greatest professions of mankind. He was moved by the farmers that made the decision to raise their families on the farm. He spoke of the joys of raising his family on the farm and the sadness he feels in not being able to farm like he once did. He remarked that his farming experience prepared him well for the work he did and encouraged the farmers to value their training on the farm because everything done on the farm opens the door to another profession. He thanked the farmers for coming to the meeting and gave them his blessings.

Mr. Bachler stated that he loves farming. He commented that farming fosters a good work ethic and teaches the value of a dollar at a very young age. He thanked Mrs. Kiraly and Ms. Kenyon for their presentation and the farmers for coming to the meeting.

Chairman Eisel commented that the Board is very appreciative of the farmers and aware of the financial impact farming has in Delaware County. In his personal business when there was a need to hire a person he would hire a farmer because he knew he would have a good person. He added that he believes in the family farm and hopes that farming will come back stronger than ever.

Office of the Aging Director Thomas Briggs pointed out that the Planning, Recreation Culture and Community Committee approved an additional \$5,000 to the Senior Meals program specifically for the purchase of locally grown food.

Mr. Donnelly thanked the farmers for desiring to do a job that so many people take for granted. He regrets that in the town of Andes he has witnessed the decline of the family farms. He thanked the farmers for attending the meeting and extended special thanks to farmer Joe Branigan, who has just recently returned from serving in the Marine Corps in Iraq.

Mr. Marshfield said that he grew up on a dairy farm and was a member of the FFA. He remarked that two of his brothers chose to become farmers. When he heard that Delaware Academy was going to do away with the FFA program he fought to keep it, adding that he believes there are now three schools with the program. He commented that people thought he was crazy to begin his chores at 4:00 in the morning but, to him it was an opportunity to listen to the sounds of nature and start his day right. Mr. Marshfield thanked and commended the farmers of Delaware County and said he will do whatever he can to support the occupation of farming.

Mrs. Schafer read Resolution No. 230 entitled Support for Agriculture and Farm Families.

Chairman Eisel thanked the farmers for attending the meeting.

For Standing Committees Reports, Peter Bracci, Chairman of the Social Services Committee called on Commissioner of Social Services William Moon to address the department's involvement with the home located at 18 Clinton Street in Delhi.

Commissioner Moon referenced an article that appeared in *The Daily Star* on Wednesday, October 24th. He noted for the past ten years the department has used this home for the placement of homeless individuals and families. The department became aware of the home's health and safety issues by the code enforcement official. Upon the notification, the people placed there by the department were removed and will return to the home after the issues cited are corrected.

Commissioner Moon also stated it is the policy of the department to place individuals in the department's care that have been convicted of sex crimes in homes located away from the general population. He pointed out that the Board approved the purchase of a rural facility that is better suited for these individuals and they are placed there.

Mr. Bracci referenced the properties that will be purchased in the Village of Delhi and asked Commissioner Moon if the same policy with regard to convicted sex offenders in the department's care will apply when placing individuals and families. Commissioner Moon answered that it would be contrary to the departments policy to do otherwise.

Mr. Utter explained that the passage of this resolution will open the door to a grant from the NYSDEC of about \$450,000 towards this project.

The resolution was unanimously adopted.

Mr. Utter offered the following resolution and moved its adoption:

The resolution was seconded by Mr. Haynes.

Mr. Utter explained that this resolution represents work over and above the original bid for the removal of additional debris from the County Route 7 corridor in the town of Colchester.

Mr. Marshfield asked for an update on County Route 7. Mr. Utter said that due to equipment breakdown, paving has not been completed. Chairman Eisel added that paving is expected to be completed by mid-November.

Mr. Homovich said that he is pleased with the progress. He advised that County Route 7 remains open only to local traffic and the necessary services to the homeowners located there. He asked that people remain patient as County Route 7 will be a beautiful new road when the work is completed.

In answer to Mr. Marshfield, Mr. Utter said that the preliminary figure for the cost of this project was about \$7 million. Mr. Homovich remarked that the \$7 million figure is quite a bit less than what was previously estimated.

Mr. Homovich stated in response to Mr. Marshfield, that the County has not seen any reimbursement to date from the Federal Highway Administration. However, it has only been four months.

Mr. Marshfield commented that he believes the sale of the ARC building is a win-win situation for the County, for ARC and the town of Hamden.

Chairman Eisel said that the sale of the building will allow the Board to downsize county government. This building is no longer needed for use by the County and is in need of costly rehabilitation if the tenants were to continue there.

The resolution was unanimously adopted.

Mr. Homovich stated it behooves us all to take a good hard look at the benefits the County receives from the New York State Police (NYSP). He said that he holds the NYSP in high esteem and the town of Colchester will always be indebted to them for their professional assistance with the June 19, 2007 flood. He thanked town of Delhi Supervisor Peter Bracci for meeting with Commander Major Kevin Molinari of Troop C in Sidney and providing the notes of that meeting to the Board.

Mr. Bachler advised that not everyone on the Board had received a copy of Mr. Bracci's notes. Chairman Eisel asked that Supervisors who did not have a copy of Mr. Bracci's notes to contact Mrs. Schafer.

Mr. Bracci commented that Major Molinari said that during the June 2006 flooding there were 2,600 calls in one day to the NYSP 911 Center in Sidney. They were able to handle these calls by bringing in people from other areas of the state to assist with the phones and dispatching during the emergency. He asked the Board to consider this as Delaware County will lose this resource if the center is relocated.

Mr. Homovich stated as a result of the town of Colchester June 2007 flooding, he witnessed resources available to the NYSP that Delaware County is not able to match or fund. The NYSP had a communications system located in a truck at the Roscoe Fire Hall that could reach any part of the world. The system is worth over \$500,000 and they have the people to run it on the scene. The County does not have the resources, the Board needs to do what is best for the people of this County.

Chairman Eisel reminded the Board that the Public Safety, Finance and Budget Oversight Committees decided to hire the consulting firm of Tech Valley Security because relocating the E911 Center is such a controversial issue. The firm will begin their appraisal very shortly and when complete, their appraisal will provide the information required for the Board to make a knowledgeable decision.

Mr. Valente thanked the committees for their decision to hire the consulting firm as he felt he did not have enough information to make a knowledgeable decision.

Upon a motion, the meeting was adjourned at 1:55 P.M.
