REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

APRIL 23, 2008

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, April 23, 2008 at 1:00 P.M. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present.

Mr. Donnelly offered the invocation.

Mr. Triolo led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Mr. Valente. Mr. Valente introduced Director of Economic Development Glenn Nealis.

Mr. Nealis provided an update on the departments of Economic Development and Watershed Affairs requests for proposals seeking universities and consultants to study the economic impact to the County concerning the New York City Land Acquisition Program. Four responses have been received and will be reviewed by the departments of Economic Development, Planning, Real Property Tax, Watershed Affairs, the Delaware County Soil & Water Conservation District, the Chamber of Commerce and two members of the Board of Supervisors. The committee expects a final decision to be made by the middle of June.

Chairman Eisel granted privilege of the floor to Mr. Utter. Mr. Utter introduced Commissioner of Watershed Affairs Dean Frazier to discuss amendments to Dam Safety Regulations. A hand out entitled: *Information for Board of Supervisors Meeting - April 23, 2008 Amendments to Dam Safety Regulations* was placed on each Supervisors' desk.

Commissioner Frazier announced that there will be a public hearing on May 2, 2008 from 10 a.m. until 2 p.m. at the office of New York State Department of Environmental Conservation (NYSDEC) in Albany to give the public an opportunity to provide oral or written comments on the proposal to amend dam safety regulations. He encouraged the Supervisors and the public to visit the NYSDEC website, www.dec.ny.gov/regulations/39559.html for more information.

Commissioner Frazier said that the majority of the information in the handout was taken directly from the NYSDEC website and there are comments in the handout that are from the New York Association of Conservation Districts, Inc. He indicated that he did not have a complete or thorough understanding of the proposed dam safety regulation changes at this time, but felt it was important to bring the subject forward.

He explained that the genesis of these proposed regulations came about, at least in part, as a result of the failure of the Hadlock Pond Dam in the Town of Fort Ann. Delaware County has 155 dams that fall into the following categories; 8 Class C dams, high hazard, 24 Class B dams, medium hazard and 123 Class A dams, low hazard. The design criteria is dependent upon hazard classifications determined by the NYSDEC.

Commissioner Frazier discussed a few of the proposed regulations. Dam ownership is identified as any person or local public corporation who owns, erects, reconstructs, repairs, maintains, operates, or uses a dam. Financial requirements associated with dam ownership are delineated with regard to the inspection and repair of the dam. He pointed out that agricultural exceptions have changed as well.

Commissioner Frazier said if the Board felt this matter was worthy of a resolution there would be time to present one at the May 14th Board of Supervisors meeting.

Mr. Homovich questioned what language would be in the resolution. He referenced the Roundout-West Branch tunnel and remarked that if the tunnel fails, it would impact the towns of Margaretville, Hancock, Downsville, Deposit and Walton. He noted that the Office of the State Comptroller's (OSC) audit regarding the Roundout-West Branch tunnel points out there is no plan in place if the tunnel fails. NYSDEC is placing a great deal of the County in jeopardy.

Chairman Eisel advised that a study has been done on the Roundout-West Branch tunnel and there is discussion of building another tunnel alongside the present one in order to shut the old one down for repair. He pointed out that it may be three or four years before the work is completed.

Mr. Homovich said there is a plan to deal with the Roundout-West Branch tunnel downstate but, he questioned how NYCDEP was going to deal with the problem up here. He remarked that he is trying to get the OSC to revisit the Roundout-West Branch tunnel audit. However, getting action from the State or City is just about impossible. He felt that if a resolution was going to be brought forward, it should be meaningful.

Commissioner Frazier referenced the last page of the handout entitled: *Delaware County Dams* and pointed out that the list of dam owners is sorted by towns. He asked the Supervisors to review the information which was received from the NYSDEC to ensure that it is correct.

Mr. Marshfield asked how the NYSDEC came up with the information on this list. Commissioner Frazier said that the NYSDEC sends a letter twice a year to all the dam owners on record.

Chairman Eisel remarked that the information needs to be updated as some of the owners in the Town of Harpersfield were incorrect.

In response to Mr. Marshfield, Commissioner Frazier said that he would provide the Board with the name and email address of the contact person at NYSDEC to report corrections and/or additions to the list.

Mr. Donnelly asked who would be responsible to notify the dam owner of the dam's classification and how would the owner know when an inspection is due. He commented that the Town of Andes asked the NYSDEC to come and inspect the dam at Little Pond, which is a State dam and the NYSDEC replied that they would not come to do an inspection because it was not their responsibility. Commissioner Frazier said that NYSDEC would most likely notify the dam owner and pointed out that the NYSDEC has established the requirements a dam owner must follow.

Mr. Donnelly extended his appreciation to Commissioner Frazier and County Planner Spencer Devaul for their presentation at a Town of Andes Board meeting on City owned land in the Town of Andes. The presentation was well received and the visuals made a real impression. Members of the town board commented that actually seeing how much land the City has acquired makes the problem register.

In answer to Mr. Hynes, Commissioner Frazier said that he is not aware of any requirement on the town or county to notify dam owners of the NYSDEC requirements. The owner of a Class B or C dam are responsible to conduct periodic dam safety inspections at specified frequencies as determined by the NYSDEC. The dam owner would have to hire an engineer to conduct the dam inspection.

Mr. Homovich suggested that the Supervisors go on-line and read how the OSC answered the Roundout-West Branch tunnel and the dam safety audits.

Congresswoman Kirsten E. Gillibrand's Regional Representative Phil Giltner, announced that the Congresswoman will be holding a watershed summit meeting. The meeting is expected to be held at SUNY Delhi. The tentative date is August 11, 2008 from noon to 3:00 p.m. Mr. Giltner asked that the Supervisors talk with him about who they might want to attend the meeting and any issues they are interested in discussing.

Ms. Molé offered the following resolution and moved its adoption:

RESOLUTION NO. 84

TITLE: PROCLAMATION OF MAY AS MENTAL HEALTH MONTH

WHEREAS, healthy individuals and healthy communities are essential elements of any strong and vibrant society; and

WHEREAS, mental health disorders and mental health problems affect people of all ages, backgrounds and at all stages of life; and

WHEREAS, mental health problems are real and common, but it is important to remember that recovery is possible and with treatment, individuals with mental health problems can lead full and productive lives; and

WHEREAS, Delaware County has made a commitment to community-based systems of mental health care for all residents; and

WHEREAS, the guiding principles of community mental health care have always been comprehensiveness, cost-efficiency, effective management and high-quality and consumer-responsive services; and

WHEREAS, the Delaware County Community Services Board observes Mental Health Month each year in May to raise awareness of mental health, mental illnesses and the stigma that exists pertaining to persons with emotional disabilities;

THEREFORE, BE IT RESOLVED that the Delaware County Board of Supervisors proclaims May 2008 as Mental Health Month in Delaware County and urges residents of the County to become educated about the benefits and importance of good mental health care and to seek services for emotional problems early from mental health professionals.

The resolution was seconded by Mr. Donnelly and unanimously adopted.

Mr. Utter offered the following resolution and moved its adoption:

TITLE: 2008 BUDGET AMENDMENT TRANSFER OF FUNDS - ROAD FUND DEPARTMENT OF PUBLIC WORKS

WHEREAS, there has been a significant increase in the cost of salt due in part to a fluctuating fuel surcharge; and
