REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

MARCH 10, 2010

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, March 10, 2010 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present except Mr. DuMond.

Mr. Marshfield offered the invocation.

Mrs. Capouya led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk reported all communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to Mr. Hynes. Mr. Hynes introduced Chief Planner Shelly Johnson-Bennett to provide an update on the next phase of the Delaware Basin Stream Management Plan Implementation.

Mrs. Johnson-Bennett introduced Delaware County Soil & Water Conservation District (DCSWCD) Executive Director Richard Weidenbach. Mr. Weidenbach announced that Stream Corridor Management Program Coordinator Scotty Gladstone retired in January 2010 and introduced Graydon Dutcher who is temporarily filling the position.

Mrs. Johnson-Bennett noted that copies of the presentation, the applications and detailed information to help complete a proposal for the Stream Corridor Management Program (SCMP) has been placed on each Supervisor's desk.

The New York City Department of Environmental Protection is providing funding in the amount of \$500,000 to the DCSWCD to start a grant program for projects or programs within the New York City Delaware River Watershed. The funded projects will be implemented no later than the end of the calendar year following the year of application. Time extensions may be granted for special circumstances.

To be eligible for this funding, the proposed project must follow the recommendations of the SCMP and the East and West Branch Delaware Basin Action Plans. The project must be with a municipality that has adopted the respective SCMP and has signed the memorandum of understanding with the DCSWCD. The applicant must be a municipality or a 501c-3 not-for-profit corporation and must have a letter of support from a host municipality.

It would be helpful for the municipalities, Mrs. Johnson-Bennett noted, if they would review their local plans and look for additional opportunities to apply for funds that would assist them in managing local streams and floodplain projects. Municipalities should also consider participating in the Project Advisory Committee (PAC) by appointing a representative to attend the PAC meetings.

Mrs. Johnson-Bennett referred the Supervisors to their handout which details the application process and deadlines for submission. In addition, she offered along with Mr. Dutcher to provide a presentation for any of the municipalities.

Mr. Dutcher commented that the process of discerning the municipalities projects and programs provides an opportunity for the municipalities to drive the DCSWCD workload.

In answer to Mr. Triolo, Mrs. Johnson-Bennett stated that the PAC will be prioritizing the projects.

In response to Mr. Marshfield, Mr. Dutcher said that an in kind contribution from the municipality would have a minimal affect on the application score.

Mr. Dutcher explained in reply to Mr. Marshfield, that the municipality has the option of hiring an engineer to design the project with DCSWCD's oversight or have the DCSWCD be the lead entity on the project and use DCSWCD's engineering services.

In answer to Mr. Marshfield, Mrs. Johnson-Bennett noted that there was no additional scoring for the dollar amount of the project.

Mr. Weidenbach stated in reply to Chairman Eisel, that a town should plan their project with the New York State Department of Environmental Conservation stream work deadline date in mind although, time extensions may be granted for special circumstances.

Mrs. Johnson-Bennett reminded the Supervisors that their protests and appeals to FEMA's proposed changes to their town's flood maps are due to FEMA by March 24th. She suggested the paperwork be in the mail by March 19th to avoid missing the deadline. Any town wanting assistance or further information should contact the County Planning Department.

Additionally, an electronic version of the New York City Watershed Economic Impact Assessment Report, the New York City Long-Term Land Acquisition Plan and the New York City Land Acquisition Draft Scope of Work has been provided to each Supervisor for their review.

Chairman Eisel granted privilege of the floor to Mr. Homovich. Mr. Homovich introduced Director of Emergency Services Richard Bell and Director of Information Technology Joe deMauro to discuss possible grant funding through the American Reinvestment Recovery Act funds to upgrade the county's public safety communication system.

Mr. Bell noted that the county has been participating in a Southern Tier Regional 911 Committee to try to reduce the cost of implementing a new public safety radio system. On Friday, March 5th, he and Mr. deMauro attended a meeting hosted by Southern Tier East Regional Planning Commission along with the consulting firm of ECC Technologies. The purpose of the meeting was to introduce what they believed to be a viable broadband stimulus application which would benefit Delaware County. Due to the rapidly approaching deadline for submission of the application, the department was given five days to review the plan in its entirety and seek the Board's approval to provide a commitment letter from the county. The completed application must be submitted by March 26th.

A multi-county local not-for-profit distribution company in which each county would have a seat on the Board of Directors was proposed. Through the use of the stimulus funds, hundreds of miles of fiberoptic network would be placed among the participating counties and

would be managed by the local distribution company.

The proposed project would provide fiber to the majority of the county's towers and eliminate much of the need for any infrastructure for those towers to communicate to each other as they would be communicating on the fiberoptic network. The county would not have to incur the cost of building and maintaining a new microwave system and would reap the benefit of a fiber system too costly for the county to implement on its own.

The local distribution company would solicit fiber for county use, provide bands and free maintenance on an ongoing basis to the counties. The remaining fiber would be available to the private sector to lease. Funds received through the leasing of the remaining bands would be used by the local distribution company to maintain the system.

He referenced his handout entitled: *Proposed OAM Route throughout Delaware County:* 136:11 miles and Consolidated Fiber Routes Estimated Construction Costs. Referencing the route he pointed out that the proposed plan did not include the lower part of the county. ION, a group that includes many of the local communication companies in the county, has an application awaiting award in that area. The application being submitted by Southern Tier East Regional Planning and ECC Technologies compliments the applications submitted by ION as it fills the voids ION is not supplying in terms of redundant network access.

The proposal has a \$3.8 million grant amount and a match that is required by the reinvestment program from local entities. The project cost for Delaware County is expected to be \$5.5 million. The State of New York has indicated to Southern Tier East Regional Planning that they will come up with 10 percent of the local match which is approximately \$384,000, leaving a local match of \$1.2 million. The county's local share can be reduced by 30 percent through in kind services lowering the county's out of pocket expense to \$800,000 or \$900,000. The local share can be distributed over a period of years as the payout is incurred over years two and three of the project after approved for implementation.

The project has to be a sustainable business model in order to be approved through the funding program. Delaware County was invited because the project requires an under served and in need of a critical public safety infrastructure upgrade to be eligible for application. It is projected that Delaware County will be a \$700,000 loss to the local distribution company. The larger counties and the other portion of the district have enough business and economic interest in this network that they show a profit in their business plan and together the overall project appears profitable. If any of our neighboring partners were to back out, Delaware County would not be invited to participate in the application based on the projected loss.

Mr. Bell felt that the project provided a viable option for the county and if awarded would complete a portion of the public safety radio upgrade. The county has to incorporate this portion of the upgrade in order to keep its towers on-line and communicating.

Mr. Triolo pointed out that the proposed project was a middle mile project and Delaware County would still have areas of public safety to address.

In answer to Mr. Triolo, Mr. Bell explained that this middle mile project for Delaware County brings the fiber directly to the tower for public safety use. The end mile service off this project is the leasing capability back to private sector business. However, the project does not directly address the county's communication problem.

Mr. Bell stated in answer to Chairman Eisel, that federal funding cannot be used to offset

local share federal funding.

In response to Mr. Hynes, Mr. Bell noted that the project is complimenting the ION project. Southern Tier East Regional Planning and ECC Technologies have worked together to create a complete plan. ION already has a plan they hope to implement in the lower portion of the county, therefore, this proposed project does not include that portion of the county.

Mr. Bell explained in answer to Chairman Eisel, that ION has already received their award in round one and has a future application in for round two of the award process. The local telephone companies, Delhi, Hancock and Margaretville, have an extensive amount of fiber in the lower part of the county already. The department has been in discussion with them about what networks they have available to help tie in the county's additional needs in that area. The local telephone companies are capable and willing to work with the county.

In answer to Mr. Marshfield, Mr. Bell stated that the county could not afford a broadband system on its own. If the county declines to participate in the project, broadband would not be an option for the county. The county would be looking at a combination microwave broadband system at a cost well over what the anticipated local share is for this project to put in a network that would be capable of meeting our needs.

In reply to Mrs. Capouya, Mr. Bell noted that the new fiber is proposed to be buried and will not replace existing fiber but fill in the voids. The proposed project would provide county to county redundancy which will allow counties to back up each other's 911 systems.

Mr. deMauro stated in answer to Mrs. Capouya, that because this network reaches across the county from end to end it creates a redundant link for communications. The option is very appealing to cell providers because they can lease the fiber and not have to come into an area and absorb the cost of laying the fiber.

In response to Mr. Utter, Mr. deMauro explained that fiber is being used in all future communication planning. It is a strong product and is compatible with existing fiber. Providers looking to lease the fiber use their own components on the end of the fiber to achieve their communication needs.

In answer to Mr. Hynes, Mr. Bell explained that L. R. Kimball has completed its job for Delaware County. The county is now in the request phase looking for an engineering firm to help develop a path forward for communications. The proposed project fits well into our plan because this has to be done no matter what system we choose. Since Kimball's presentation, several other viable options have been presented to the county for consideration.

Mr. Bell stated in response to Chairman Eisel, that the department has put together an application that is considered by Congressman Murphy's office to be very strong. The application includes funds for infrastructure build out, replacement of cell towers, and replacement of failing equipment and buildings. There is also money allocated in the application for the backbone work and tower to tower communication work. If the decision is made to participate in this proposed project the question of frequencies will have been determined for the county.

Mrs. Capouya asked if there were options other than increasing taxes to raise the funding for the local share. The project is a benefit to emergency services and infrastructure for private industry but she felt that these were difficult economic times to raise taxes.

Mr. Bell stated that he did not have an answer for the first part of her question but, noted there would be a cost to the county whether we participate in this project or move ahead on our own. The cost of maintenance on our existing system is about \$100,000 a year. Using this example, if the county decided to participate in the proposed project it would see a long term savings of \$2 million over a period of twenty years.

In answer to Mr. Utter, Mr. Bell commented that whether participating in this project or moving ahead on our own the time restrictions were comparable. The county will meet the 2013 narrow banding deadline with minimal costs but, we are actually looking at a shorter time frame than 2013. The county is seeing more predicative interference levels which will force us to migrate from the frequencies we are using.

In reply to Mr. Dolph, Mr. deMauro said that network leasing will be available on a first come first serve basis. Any provider desiring to provide last mile services in this area could do so cost effectively creating many attractive options for local businesses.

In response to Mr. Donnelly, Mr. Bell explained that the county is in the process of interviewing engineering firms to assist with a frequency study.

Mr. Homovich commented that the county has been working on this for a long time and is now in a situation where we have to replace our current system. It is imperative that we look at all the options available both in funding and in infrastructure projects. He felt this project provided the county an opportunity for expansion and a better communication system. He thanked Mr. Bell and Mr. deMauro for all the work that has been put into this grant.

Mr. Marshfield remarked that he sees this as a step in the right direction and hoped the grant would be awarded.

In answer to Mr. Marshfield, Mr. deMauro stated if Broome County decided not to participate in the project both Otsego and Delaware Counties would be out. If Otsego drops out of the project there is a 95 percent or higher chance that Delaware County would not be asked to participate based on the projected losses.

Chairman Eisel remarked if all the counties stick together we will have a system that is far superior than what we could provide for ourselves. He apologized for presenting this as a not pre-filed resolution but, due to the time frame felt it was imperative that the Board make a decision on this matter.

Mr. Bell stated in answer to Mr. Valente, that the level of commitment at this time is the application. If the application is awarded we are committed to participating in the project.

Mr. Homovich commented that part of the eligibility requirement is an under served public safety population and our participation meets that eligibility requirement.

Chairman Eisel thanked Mr. Bell and Mr. deMauro.

Chairman Eisel advised that the census workers have been around. He has received, completed and returned his census form and encourages all county residents to do the same. The census affects the county's political representation and how the government distributes funding to the states.

Mr. Bracci noted that for several years he has been working to correct the county

population for the Town of Delhi. There are 3,000 students attending SUNY Delhi and the previous census indicates a population of 900.

Chairman Eisel granted Mr. Rowe's request to abstain from voting on this resolution.

Mr. Valente referenced the attached bid summaries and questioned the meaning of First Choice and Second Choice. Commissioner Reynolds explained that the first choice is the lowest of the two bids but if that company is unavailable for any reason the department has the option to accept the second choice. Mr. Valente asked for glossary of terms to be included with the bid summaries in the future.

WHEREAS, state parks provide a substantial benefit to local businesses, the area's economy and State and local taxpayers, as well as all the people from near and far that utilize the parks; and

WHEREAS, the Bear Spring Mountain campground is an integral part of our historic Cannonsville recreational boating program which, along with its fishing access and forested campsites, makes Delaware County an ideal summer escape; and

WHEREAS, local state parks, such as Bear Spring Mountain, are an alternative form of recreation and enjoyment for families throughout the region and the NYC Metropolitan Area who have been affected by the economic downturn; and

WHEREAS, Bear Spring Mountain represents a major tourism draw for Delaware County and crucial source of revenue for local businesses and residents.

NOW THEREFORE, BE IT RESOLVED, that the Delaware County Board of Supervisors hereby declare its opposition to the proposed closure of the Bear Spring Mountain campground; and

WHEREAS, producing food is a basic need, and unless the legislature seriously rethinks the aforementioned legislation it will jeopardize our farmers' ability to produce locally grown food for our people; and

WHEREAS, this proposal forces mandates on our family farms that will put New York at an extreme competitive disadvantage, seriously jeopardizing the long-term viability of the upstate economy before passing legislation that wrecks it; and

WHEREAS, the amended Senate Labor Bill would have a tremendous impact on New York's smaller farmers, while also putting unsustainable pressure on larger family farms that provide the bulk of the fresh New York grown products; and

WHEREAS, the Bill creates an overtime regulation that is more stringent than the vast majority of other states. The only other state with more strict labor mandates is California, which has an agricultural industry more than triple the size of New York's family farms; and

WHEREAS, the new Senate Bill also pushes for collective bargaining. Ninety-nine percent of New York's farms are owned by families - not huge corporate manufacturers with staff to negotiate with New York's powerful unions; and

WHEREAS, food is a basic human need, and this legislation seeks to ensure that local farms will not be around to produce locally grown food for local people. This bill would force us to turn our farms into factories, to meet these onerous labor mandates that virtually no other state in the union has. It's yet another example of Albany seeking to drive businesses - and farmers - out of New York.

NOW, THEREFORE BE IT RESOLVED, the Board of Supervisors strongly opposes the aforesaid Bill as said Bill will put New York agriculture at a disadvantage, will hurt our ability to thrive and sustain our most important state industry.

BE IT FURTHER RESOLVED, that certified copies of this resolution be forwarded to New York State Governor David A. Patterson, Senators John Bonacic and James Seward, Assemblymen Peter Lopez and Clifford Crouch, Assembly Speaker Sheldon Silver and the New York State Association of Counties.

The resolution was seconded by Mr. Valente.

Mr. Smith noted that the mandates presented in these bills will place an added hardship on our farmers. The bills were brought to his attention by the President of the Delaware County Farm Bureau Roger Hamilton. This resolution is in opposition to these mandates.

Mr. Valente commented that he runs a seasonal flower and greenhouse business and is required to pay unemployment to his employees even though they are aware at the time they are hired that they are seasonal. Farming does not fit the traditional thinking of what is considered a seasonal business and these mandates will prove to be difficult to impossible for our local farmers to meet.

Mr. Bracci commented that these mandates along with the prevailing wage are just another attack on upstate New Yorkers.

Senator Bonacic's Community Liaison Tina Molé, advised that Senator Bonacic is in opposition of these bills.

Mr. Marshfield stated that within the past few weeks three dairy farms were sold, one in the Town of Kortright and two in the Town of Delhi. He felt if these bills passed it would be another nail in the coffin for the farmers.

Mrs. Capouya commented that she felt laws like these come out of the experience of states with large factory farms. Many of the legislators are not aware of the differences in farming. She opined that these bills appear to be more of a mistake in thinking than malice.

Mr. Valente remarked that this is another example of the urban mentality.

Mr. Utter offered an example of urban thinking from his time as President of the Farm Bureau. The Secretary of Agricultural at the time was speaking in an urban area in support of raising the parody of dairy products. The audience was very sympathetic to the plight of the farmer but, just could not understand the purpose of funding the farmers when everything they grow could be purchased at the grocery store.

The resolution was unanimously adopted.
