Mr. Marshfield offered the invocation.

Mr. Taggart led the Board in the Pledge of Allegiance to the Flag.

The Clerk requested nominations for Chairman.

Mr. Merrill nominated Tina Molé. The nomination was seconded by Mr. Eisel and Mr. Davis.

Mr. Gladstone nominated Wayne Marshfield. The nomination was seconded by Mr. Valente.

Mr. Eisel moved to close the nominations.

Upon a vote by a show of hands, Tina Molé was re-elected as Chairman of the Board with two dissenting (Gladstone, Marshfield).

County Clerk Deb Goodrich administered the Oath of Office to Ms. Molé.

Upon a nomination by Mr. Davis, seconded by Mr. Pigford and Mr. Vernold, Mark Tuthill was unanimously re-elected as Vice Chairman.

Upon a nomination by Mr. Eisel, seconded by Mr. Merrill, Christa M. Schafer was unanimously re-elected as Clerk of the Board.

Upon a nomination by Mr. Davis, seconded by Mr. Eisel, Amy Merklen was re-elected as County Attorney with two opposed (Gladstone, Marshfield).

Upon a nomination by Mr. Gladstone, seconded by Mr. Eisel, Arthur Merrill was unanimously re-elected as Budget Officer.

Chairman Molé thanked her colleagues for their support and to all the County employees for their hard work during the past year and stated that 2019 was a success for Delaware County. The goals this Board set out to do last January have been met. The County is on track to bid the new Mental Health facility in Walton this winter with construction to begin in the spring. We established a public defender's office, renovated space at 97 Main Street and that office is now fully staffed and operational. The new elevator at 97 Main Street will be completed by the end of this month. Delaware County DPW committee and staff under Sue McIntyre's leadership spent the entire 2019 diligently seeking sites for our new highway facility. It is anticipated that a presentation will be given at the January 22 Board of Supervisors meeting on a hybrid location proposal. And last but not least, the Board of Supervisors has kept the County budget at less

than a 2 percent increase for the last three years. This is a direct result of the Supervisors working closely with their committees and employees to keep costs down while maintaining efficiency which is no small task. Two thousand twenty in Delaware County is bright. The County will move forward on two major construction projects as well as relocate the Board of Elections and the Veterans Service Office.

Ms. Molé welcomed the three new supervisors and said she looks forward to this year.

Chairman Molé noted that all standing committees will remain the same until changes are announced at the January 22 Board Meeting.

The minutes of the previous meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Chairman of the Capital Projects Committee Mark Tuthill announced that the committee expects to offer a prefiled resolution at the next meeting authorizing them to go out to bid for the Mental Health facility. Complete drawings and specs are being reviewed and other than a few minor tweaks, they are pretty much ready to go.

Supervisor Marshfield stated the Committee has unanimously agreed that Sylvia should be the County's next Commissioner. She has over 30 years of experience in the department from case worker on up. She has been the deputy commissioner for a number of years and has been the interim commissioner the last several months and has done a splendid job. The Social Services Committee feels that nobody can top her for the position. They will be looking for a deputy commissioner to understudy.

TITLE: APPOINTMENT OF YOUTH BUREAU DIRECTOR

That was the first time she had really talked to him. She came away with several things from that meeting. One, he had a colorful way of talking.
