CHAIRMAN: Ok. Resolution No. 68* - I will bring that up and move for its adoption – Art Merrill/ I'll Second it – Taggart

CHRISTA: Authorize County Treasurer to Cancel 1% Interest Charges on Delinquent Real Property Taxes for the Month of April 2020.

CHAIRMAN: This is only for the delinquent property taxes prior to 2020.

CETTA: It all started because of another County (Cayuga County). We were under the assumption when we were during discussion that it was for this April's 1%. It is all based on because of coronavirus. I am not sure why we are going back two years ago and she focusing on it right now. [Can't understand] According to Section 904, the copy we obtained, the Governing body, not the Towns, the County issues the warrant no later than 31 of December. The warrant is good through March, the 1st of April on.. the County is the governing body. At some point, the Towns all agreed to continue to collect the taxes with the County at 1% going to the town. The County as we understand it, is the Governing Board.

MERKLEN: Here's the difference of opinion. The taxes are not returned in Delaware County until the end of April or May 1st. We give an extra month to the town. But this does not affect the 2020 taxes. This affects the past taxes of 2018 and 2019.

CETTA: The whole discussion right at the beginning was because of the coronavirus and it was understood by a number of people that it was for the 2020 tax season.

MERKLEN: But it is not.

CETTA: Why did it changed?

MERKLEN: I don't know that it has ever been for the 2020 tax season. It was for town taxes. We are not doing 2020 it is for the past 18 and 19.

CHAIRMAN: Just so it is understood, Amy came in and said that it was for the month of April, the 1% that the Towns were collecting.

MERKLEN: It is not for that.

CETTA: Why did that change? It was understood it was for this year's taxes and solely based on because of the coronavirus.

CHRISTA: The treasurer also collects for the delinquent taxes. This 1% that she is asking to be forgiven helps those taxpayers that are going to be paying for the delinquent taxes to give them a break because of the virus as well. It gives them that 1% penalty to fix that. As far as the tax collectors for the 2020, that's a town by town decision whether or not they do that. The County does not get that penalty.

CETTA: I disagree. From 1 April on – the County takes the decision to raise that 1% for 20.

CHRISTA: But the County is not the one that is collecting.. the Towns keep that 1%. A long time ago the decision was made that the Towns would – that Resolution is adopted in the month December – authorizing the towns to collect up until March 31st. After March 31st, those taxes are to be returned to the County Treasurer's office. Historically, the warrant has been extended until the end of April.

CETTA: The County extends April 1. So from 1 April on, the County is governed by...would you agree with that?

CHRISTA: No, I would not – because the County is extending it. So they are not. YOU are keeping that money, not the County. That 1% penalty that is being collected for the month of April, that belongs to the Town. The County cannot tell you.. you can't collect that anymore. The

Towns are to make that decision, not the County. That is based on the research we have done. And according to the County Treasurer as well, she is in agreement with that.

CETTA: That why it says for delinquent.

CHRISTA: There are four towns that have waived that 1%. Walton, Sidney, Delhi and Tompkins and Deposit...so five.

CETTA: This whole conversation started around the coronavirus.

CHRISTA: This is also stemming around the coronavirus. The 2020 part and the delinquent taxes are concerned.

CETTA: Let me ask you this, if someone has delinquent taxes from 2018 and they haven't paid their 2020 yet, and come in with a \$1,000 cash, what tax did that go on? The most recent tax..correct?

CHRISTA: But that's what the County Treasurer is collecting. Now we are looking at what the County Treasurer is collecting. This resolution is just purely for the County Treasurer. So if my taxes were delinquent for 2018, I would come in here and pay the County my 2018 taxes and the County would forgive that 1% fee for the month of April.

CETTA: The reason for that is that the County office building has been closed here – they haven't been able to get in and pay it.

CHRISTA: Exactly

EISEL: That's 2018 and 2019 right?

CHRISTA: Correct

CETTA: Correct me if I am wrong, each month that a delinquent tax is 1%?

CHRISTA: I believe that the penalty is 1% monthly.

CETTA: So if you did not pay your taxes in 2018, there is 24% interest on that?

CHRISTA: A little bit more than that. There is a penalty, there is advertising fees, there is other fees that the treasurer charges for delinquent taxes that are added onto that base. So when 2020 comes back, the Treasurer has a charge that is added on...5% penalty ...I believe it's 5% in May and from thereon its an additional penalty. Then if there is any other fees incurred such as advertising, the Treasurer adds that on. There are other charges that are added on to that tax when your tax collector returns that to the County.

CETTA: So if somebody owes a total of 5% additional penalties and interest on that 2018 tax, we are going to reduce it by 1% to 34%?

CHRISTA: You are going to reduce that 1% penalty that would have been charged for April. You are not forgiving the past penalty, just that additional 1%.

CETTA: For the one month.

CHRISTA: Correct..because the office is physically not open.

CETTA: All the Towns have Town tax collectors that are not collecting taxes at this time. Our collector is working off hours. I'm trying to assess what impact the 2020 tax collection is having on their town residents that are not able to pay their taxes this month.

HAYNES: I think that most Town Clerks are open by appointment.

CHRISTA: Or they have a drop box on the outside that they put in.

CHAIRMAN: Or mail slot.

DAVIS: We have one. The office is closed but we are 85% done collecting taxes.

MERRILL: My tax collector did not want to forgive the 1%.

EISEL: Neither did the Town of Harpersfield because the building ...then she would have to cut checks back to the people.

DAVIS: Same thing.

EISEL: Let's vote on this.

HINKLEY - I will bring that up and move for its adoption / I'll Second it - Marshfield

KOSIER: I'm from the Town of Stamford, my wife was from Roxbury, her aunt and uncle lived next door to Tom and his wife. So they always got to see him that way. He was always a gentlemen, always very professional in every part of his life and everyone is going to miss him.

TAGGART [hard to hear]: I served with Wayne also via the Finance Committee. Tom was a teacher, leader...a great person. He will be missed.

VALENTE: I will bring that up and move for its adoption / I'll Second it - Eisel

CHRISTA: Occupancy Tax Disbursement Approval - Economic Development

CHAIRMAN: Allyson, that was Valente that brought up the Resolution

AMP: Got it

CHAIRMAN: Any questions on this resolution?

GLADSTONE: What was the total number of proposals that actually asked or requested in this. I see there are 44 accepted for \$222,000 and change, but how much was actually not accepted. Just in curiosity.

MERRILL: I do not remember the exact number, but I am going to guess somewhere around 55 to 57.

VALENTE: I think it was 55.

GLADSTONE: Ok thanks Art and Dennis.

CHAIRMAN: Are there any other questions for this Resolution?

VALENTE: Just to point out the impact of the current situation, we are watching the disbursements...if events get canceled that were funded by this and it goes back into the pool to be disbursed next year. If it is a project that can be postponed successfully and commit that money to them and if they have to postpone it, it's the next season, it is going to be allowed.

GLADSTONE: After hearing Art and Dennis say about the total number of requests, its amazing that 80% of them have been accepted which that's a major, major statement right there.

VALENTE: I agree.

MARSHFIELD: I have a question for Dennis. You may not be able to answer it. It is only for my...I received one of these grants last year and it has not been completed. I gave a midyear report to Glen about this and I think one of the reasons it has not been completed is because I was using a vendor that is being used extensively for this this pandemic. Do you know Dennis, if there was a time restraint on when this money had to be spent?

VALENTE: My understanding, not under these current circumstances, Art might add more to this,

MERRILL: I don't believe there is any time permitting for this venture. Our only criteria is we do not grant a new application for an application that is somewhat delinquent in the past and the delinquency is usually the final report or final summary of what they did.

MARSHFIELD: It has been a year now that I got it and it is probably half spent and I gave the report to Glenn, but it has not been completed and I did not know what the time constraints on it were.

MERRILL: I suspect there won't be a time constraint.

VALENTE: I agree.

MARSHFIELD: Yup ok thank you.

MERRILL - I will bring this up and move for its adoption – Art Merrill/ I'll Second it – Gladstone

CHAIRMAN: Christa please call the roll.

CHAIRMAN: Ok. Just a couple of quick things. The COVID-19 – I'm sure you are all aware that the Governor has extended his pause Executive Order so we will continue to do what we have been doing for the last few weeks until at least April 29. So we will see as we approach that date whether we extend it or we will be back to work. Also, there have been no new cases that we have been notified of today. That may change later in the afternoon, but we are still at 42 cases and 5 of those cases are that individual is in another county. They just put their primary residence as being in Delaware County. Other than that, does anyone on the Board have any other business that they would like to discuss?

MARSHFIELD: I kind of do there. OK. The Finance Committee heard my spiel on it, I won't go to that extreme, but the State Budget is in such an invisible flux that we don't know exactly what is going to happen for funding to the counties to the point where this morning, the Finance Committee decided that rather than pay a sizable amount down on the new Mental Health building that we would bond it, which would leave us a little bit of slack for times when we get cut or we recover from this pandemic. But just in a nutshell, the Medicaid caps were preserved,

however, the State has the right to go in on April 1st, which we are past and I have not heard anything, May 1st and July 1st and review their budget status and then they have the right to go in and cut funding to the counties to a level that would make them more solvent. There is going to be a new... counties are going to start contributing to a new fiscally stressed hospital and nursing home pool. It's listed in a chart that Delaware County's part of that, out of our sales tax, is going to be \$130,096. The Association of Counties also stressed that counties should immediately plan for cuts and state aid for SNAP, agricultural programs that resolution that we passed did not make out too good because they cut Ag programs by \$2 Million. They are going to reduce aid to the community college fund by \$31 million statewide. How much of that effects Delaware County, I don't know. They are going to reduce the TANF and FFFS reimbursement of their social service programs by \$25 million to the counties. How much of that exactly is going to be our County's responsibility I don't know. I would say that our Chips remained at the same level, but it's on the chopping block. The shortfall that the State may see, and they are projecting a shortfall, of \$10-15 billion. Of course they do not know how much the Feds are going to pick up for them, so everything is sort of in a flux right now.

EISEL: They have a \$6 billion short fall to borrow this right?

MARSHFIELD: Yeah they had a \$6 billion before, but they figure when they come out of this, it will be \$10-15 billion. They have banned fracking permanently in the State.

EISEL: Smart move right?

MARSHFIELD: Yeah, and one good thing in my mind and the Board may not agree with that is that they did not legalize - recreational marijuana. They made a couple of minor steps forward in the bail reform, but it is still lacks a lot of tweeking. Anyways, that is basically the programs that we know so far the association of counties trying to analyze the effects of everything on specific counties, but I can assure you that everybody's sales tax gotta take one hell of a dip...we don't know how much. We won't know until the year, but you can see, like George said, the price of gas and consumption of gas and that is our main driver for sales tax is ...I mean we put \$20 million in our budget for sales tax and I will be damn hard to come up with that in my mind. That's all I wanted to say.

CHAIRMAN: I am assuming that we are all a member of the County Association of Towns, that we are all getting these emails on the updates of the budget. We are in dire straits and I don't see it getting any better any sooner. Is there anybody else that has anything they want to comment on?

ELLIS: My question is our chip money is in jeopardy or they are saying that is one of the items on the chopping block. What happens if the Chips work is done and we submit our invoices and paid vouchers on that, are we going to be reimbursed on that or are they going to chip away from that, not that level we are expecting to get back.

MARSHFIELD: I think Jim, they are reviewing it early on. I know they said April 1st, May 1st and July 1st. I suppose that's before you get into the heavy duty, but some of them will be doing their road work by the 1st of July. I don't know. I told my highway Superintendent guy to take his chips money and take 15% of it right off the top and don't figure on spending that until we hear from the State.

VALENTE: Sue McIntyre mentioned that in this morning's DPW meeting that getting your work done early does not insulate you from the cut. So even if you have your project built before the cut, you are still subject to the cut.

MARSHFIELD: Thank you Dennis.

ELLIS: Does that 15[%] enough to go away or not spend Wayne?

MARSHFIELD: The Association of Counties says that we should start planning immediately for cuts of 15%. So I don't know you may want to say well let's do 20% just to make sure. That's what I told my Highway Superintendent. Go to Town, do your chips work but back off on about 20% for a little bit mid to later in the year.

EISEL: Wayne or Dennis, do you know whether the 15% to 20% is that the supplemental that they give us for Chips above our base?

VALENTE: I think it's across the Board. [Hard to hear]

EISEL: Ok thank you.

CHAIRMAN: Any questions or comments?

MARSHFIELD: The only reason I brought all of this up is because everything is such a big UNKNOWN SPEAKER for towns and counties now. And how you determine to manage it is crap.

CHAIRMAN: Do any of you Supervisors have any meetings planned in the next week or two that you are aware of? Any committee meetings?

MARSHFIELD: Social Services has on the 20th

CHAIRMAN: Is that regular time Wayne at 9:30AM

MARSHFIELD: Yes
