REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

JULY 22, 2020

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, July 22, 2020 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mr. Eisel and Mr. Cetta.

Mr. Marshfield offered the invocation.

Mr. Davis led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Mr. Marshfield offered the following resolution and moved its adoption:

RESOLUTION NO. 110

TITLE: 2020 BUDGET AMENDMENT SUMMER YOUTH EMPLOYMENT PROGRAM DEPARTMENT OF SOCIAL SERVICES

WHEREAS, the Delaware County Department of Social Services is the designated local agency to administer the Summer Youth Employment Program; and

WHEREAS, funding is to be used for summer youth employment and education training for economically disadvantaged youth and is 100% reimbursed.

NOW, THEREFORE, BE IT RESOLVED that the 2020 Budget be amended as follows:

Mr. Marshfield stated this resolution is for federal funding that just came in. The funding is for economically disadvantaged youth and the goal is to start the youth employment program. Summer youth who want to work as well as employers who can use the help are lined up and now that they have the funding, they are planning to start the program by next week.

Mr. Marshfield indicated that positions are still available in the employment program for non-economically disadvantaged youth. Anyone who has questions on either of these programs can contact the Department of Social Services or Lara Yambor in the Youth Bureau.

Ms. Whitney confirmed Mr. Marshfield's statement that all of these COVID-19 resolutions are for federal grants that are passed through to the state and Delaware County receives the funds from the state.

In answer to Ms. Molé, Ms. Whitney stated that all the funding coming in will be going right back out. Part of the money will be used to cover the additional personnel costs incurred during the COVID-19 shutdown.

In reply to Mr. Marshfield, Ms. Whitney confirmed this is one-time funding. She expressed that COVID-19 grant funding needs to be spent first and she expects it will be spent by the end of the year as this year, any remaining program funds will be allowed to be carried over to 2021 which is unprecedented.

Mr. Taggart commented that Office for the Aging received \$189,782 in these COVID-19 grants which is a great help.

In other business, Budget Officer Arthur Merrill stated that the tax cap for the coming year is 1.56. The idea of 2% is a misnomer. The County will not exceed the tax cap, but the townships will also be at 1.56. It's a tough number to work with this year.

Ms. Molé indicated that some County reimbursements are based on the County not exceeding the cap. Just meeting the raises and insurance increases have a deep impact.

Mr. Vernold commented that these amounts alone will pretty much wipe out the tax cap.

Mr. Merrill said an additional challenge will come with reduced reimbursements from the state.

In response to Mr. Marshfield as to if the County has a carryover from last year, Clerk of the Board Christa Schafer said we do.
