The Clerk called the roll and all Supervisors were present except Mr. Davis. Supervisor Pigford attended via Zoom.

Mr. Marshfield offered the invocation.

#### **RESOLUTION NO. 97**

## TITLE: OPPOSITION TO MANDATED FAMILY ASSISTANCE RESPONSE (FAR) DEPARTMENT OF SOCIAL SERVICES

WHEREAS, there is pending legislation in the New York State Senate, introduced by Senator Jabari Brisport, seeking to require all New York State Local Department of Social Services Districts to implement a Family Assessment Response (FAR) program. Currently, FAR is a "differential response" to Child Protective Services Investigations that is optional for counties to participate in.

WHEREAS, since 2008, the New York State Office of Children and Family Services (OCFS) has approved the applications of twenty-nine (29) counties to implement a FAR program. Of those twenty-nine (29) local districts, only sixteen (16) continue to employ FAR as a response to child protective reports. It has been reported by former FAR counties that the overall approach to FAR cases is virtually identical to that of a traditional Child Protective Services (CPS) case, with the major exception being that FAR cases are not "determined (indicated/unfounded)" at the closure of the report. Some counties that withdrew from the FAR program reported that adding another unit to the local child welfare landscape caused dissention among staff and that the additional expectations/requirements of maintaining another child welfare unit became unmanageable. It was also reported that FAR did not necessarily result in a reduction of required child welfare interventions (i.e., family court, removals).

**WHEREAS**, implementing and maintaining a FAR unit would be an unfunded mandate that would require additional casework staff, additional training, additional supervisory staff, and additional office space.

**WHEREAS**, the Delaware County Department of Social Services respectfully requests that the Delaware County Board of Supervisors pass a resolution objecting to Senator Brisport's proposed legislation to mandate counties to develop and implement a FAR program. Delaware County Department of Social Services continues to support FAR as an optional differential response where the decision should remain with the local districts as to whether to implement this service. **NOW, THEREFORE, BE IT RESOLVED** that the Delaware County Board of Supervisors, formally and entirely, object to any legislation that would mandate local Social Services Districts to develop and implement a Family Assessment Response (FAR) unit.

The resolution was seconded by Mr. Vernold.

Mr. Marshfield stated this is a time-sensitive resolution as this would be a mandated program that is essentially going to duplicate a program we already have except that this program is going to require more staff, more training, etc. He introduced Commissioner of Social Services Sylvia Armanno for further explanation.

Ms. Armanno stated that basically this program has been around for a while. There are 16 counties that use this program already. A number of counties tried this program and then stopped because of the cost and duplication of work involved.

Ms. Armanno further stated someone has decided that this should be a mandated program. She has studied the program and spoke with other commissioners and she does not believe this is worth the money it cost to run nor do they have the room to add staff to run it. She stated they are against the mandate not the program. It is fine if other counties have found it works. Others have decided to try it and it did not work, but many counties have just declined to get involved in the program.

She believes it is a lot of money for what they already do and she does not believe our county would be better for it. She noted that most of the counties that are not using the program are smaller counties. She asked the Supervisors for their support to not mandate this program.

Ms. Armanno agreed with Mr. Taggart that this is an unfunded mandate. She expressed her appreciation to the Supervisors for their support to reject the mandate.

The resolution was unanimously adopted.

Mr. Eisel offered the following resolution and moved its adoption:

### **RESOLUTION NO. 98**

### TITLE: IN MEMORY OF HARRY A. PETERSON

**WHEREAS,** Harry A. Peterson passed away on April 15, 2021 having served as Town of Harpersfield Supervisor from January 1, 1982 to May 20, 1987; and

**WHEREAS,** he served with distinction and will be remembered for his dedication, community service and hard work.

**NOW, THEREFORE, BE IT RESOLVED** that the Delaware County Board of Supervisors extends its sympathy to the family of Harry A. Peterson and recognizes with gratitude his contributions to this County, his Town and neighbors.

The resolution was seconded by Mr. Marshfield.

Mr. Eisel stated that Mr. Peterson was an amazing person. He was town Supervisor for almost 6 years and served on the town board for 6 years. He was highway superintendent for 17 years and he rebuilt the town roads and they have beautiful, great roads. He served on many boards. He was on the Delaware County Electric Cooperative (DCEC) Board as a trustee for 33 years. He owned and operated a sawmill and he had a farm at one time. Mr. Peterson was very conservative and was easy to talk with. He was an all-around good guy and he really made quite a contribution to their town.

Mr. Marshfield commented that Mr. Peterson was Supervisor when he was on the council for the town of Hamden and they would kibitz back and forth quite a bit. Mr. Marshfield noted that the supervisor role of going to meetings really was not Mr. Peterson's thing. Although he was tied in as Supervisor, he resigned before his term was up. He went from supervisor to highway superintendent because then he could do what he really loved to do. Mr. Peterson was a great person. He was a hands-on guy. He was from the old school. He liked to see his roads and he liked to see his employees work hard. He was a good, old-fashioned guy. He loved sawmills and he had his own. In fact, he died looking at sawmill equipment, doing something he really loved. He was a hardworking man.

The resolution was unanimously adopted.

Mr. Eisel offered the following resolution and moved its adoption:

Mr. Eisel stated that Mr. Hill had a farm and a maple syrup business and was very involved in the community. He served on the Soil & Water Conservation District Board and was

a state representative for them. He was a member of the state NYS Maple Producers Association and a member of the Grange. He was Town Supervisor for 7 months and was on the town council for 16 years and deputy supervisor for 4 years. He contributed immeasurably to their town. He will be missed.

Mr. Kosier shared that he grew up with Mr. Hill's children and one thing that Dennis and his wife did every year was to bring a bus full of inner-city children to Delaware County through Fresh Air Kids. They had them for the summer on their farm. Many of them came back year after year to see him. It was a great honor knowing him.
