REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

JUNE 22, 2022

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, June 22, 2022 at 1:05 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present.

Mr. Marshfield offered the invocation.

Mr. Kosier led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous Board meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Chairman Molé introduced the new DEP Department of Environmental Protection (DEP) Commissioner Rohit Aggarwala.

Commissioner Aggarwala thanked the Board for giving him the opportunity to attend the meeting and to say hello in person. He was appointed as Commissioner of DEP by New York City Mayor Eric Adams a few months ago. He expressed it is a great privilege to serve in this role, as DEP is a critical agency for New York City. DEP has a storied past and a world-renowned set of assets in a system that is an example to people all over the world in terms of not only how much they do providing 8.5 million people in the City along with 1 million people north of New York City with their water but doing so in a high quality, environmentally sensitive approach. The Filtration Avoidance Determination (FAD) and the partnership they have with the Watershed is an example to cities and jurisdictions around the world for how they think about the combination of urban needs and watershed needs. He acknowledged he is still learning. This is a complex agency with complex relationships but he knows full well how important the watershed and how important Delaware County is to DEP and to the people of New York City and to the City's future.

Commissioner Aggarwala relayed a sense of some of the things he is thinking about in the spirit of which he and Mayor Adams would like to work with the County. They know that half of their water comes from Delaware County. They know that is really important. They also know that being part of the watershed has both it benefits and its challenges. He is aware of that. He is aware and proud of the extent to which DEP makes a big contribution here. They have a lot of people employed in Delaware County and elsewhere in the watershed. He hopes the Supervisors appreciate that he believes that there is positive contribution that some of their open space programs make. He also knows that there are real concerns and real challenges with

restrictions that are placed on how the land is used and with the way they have historically acquired land. He respects the fact there has to be a partnership where in the spirit of this meeting's invocation, people may have disagreements but hopefully they have the wisdom and the courtesy to work them out in a thoughtful way and towards the mutual objective in the achievement of goals.

He believes there is a huge opportunity for them to continue and to strengthen the partnership that New York City and Delaware County has. As an example, a contract they have with the County for road and infrastructure work seems to be very beneficial to both sides. He is excited to think creatively about whether there are other similar things they can do. He is aware many Supervisors have been very helpful and supportive in the changes they have recommended and they are optimistic the State Department of Health will put forth in the revisions to the FAD which will allow them to make changes to the Land Acquisition Program (LAP) and he believes those changes are things Delaware County supports and they see are also in their best interest.

Commissioner Aggarwala said he also believes there is a huge opportunity to work together to economic development here in Delaware County and the rest of the watershed because frankly, it is in New York City's long-term interest that the watershed be economically healthy. He just had the opportunity to meet with the Watershed Agricultural Council (WAC) and he met with the Catskill Watershed Corporation (CWC) staff earlier in the day. The FAD is not sustainable if it is a true drain on the region's opportunities. They have to make sure that it works for us as much as it works for them.

He expressed that with the fact that he is new and still learning and likely to err, he hopes Supervisors will be honest and polite when they let him know what those mistakes are. He will do his best to grow and learn from those mistakes. He believes Mayor Adams is a creative thinker and is interested in government doing things differently. He believes Mayor Adams has a broad perspective of what it is in the interest of New York City and that will include thinking about the extent to which the people in the watershed and the governments in the watershed are their partners and they we all have a very deep mutual interest.

He thanked the Board for being a partner to him and for the help they will give him, and he pledged to do everything he can to be a good partner.

Each Supervisor introduced themselves to the Commissioner and announced if they served on WAC, CWC, or CWT.

Ms. Molé thanked Commissioner Aggarwala for attending and introducing himself.

WHEREAS, the Delaware County Office for the Aging is in need of purchasing a new bus for the agency's transportation system; and

WHEREAS, Don Brown Bus Sales, Inc., pricing for a 2023 Ford All Star 14-passenger bus with a wheelchair lift is \$95,410.00; and

WHEREAS, Don Brown Bus Sales, Inc., has offered \$17,000.00 as a trade-in value for OFA Indy VI, a 2016 Ford bus reducing the cost of the new bus to \$78,410.00; and

WHEREAS, the Delaware County Senior Council will be gifting the agency with \$78,410.00 to cover full payment for the new bus for the agency's transportation system; and

WHEREAS, there will be no County funds involved in the purchase of this bus; and

WHEREAS, it is appropriate to approve the purchase of the new bus and revise the 2022 Budget to accommodate this purchase.

WHEREAS, additional staff support is necessary for the Department to successfully address these new opportunities and areas of focus.

WHEREAS, Resolution No. 135 of 2021 accepted funding from the New York State Public Health Corps (NYSPHC) Fellowship Program to build public health capacity to support COVID-19 response operations and increase preparedness for future public health emergencies; and

WHEREAS, the number of NYSPHC positions to be in service for an LHD and the associated grant eligibility are based on the LHD's county population and health outcome indicators; and

WHEREAS, the NYSPHC Fellowship Program will collaborate with local public health departments to match and place positions based on the needs articulated by the local county public health and through this partnership, positions will help address the local public health needs currently through July 2023; and

WHEREAS, NYSPHC Fellows serving Delaware County will augment the local health department capacity to respond to current emergencies, provide health education and program services to inform and protect communities, improve outreach and assistance to vulnerable communities and directly assist with local COVID-19 and other communicable disease public health response activities.

TITLE: RESOLUTION URGING THE NEW YORK STATE DEPARTMENT OF EDUCATION TO ADJUST PRESCHOOL TRANSPORTATION REIMURSEMENT RATES FOR COUNTIES SERVING CHILDREN IN RURAL AREAS DEPARTMENT OF PUBLIC HEALTH SERVICES

WHEREAS, the County is required to provide transportation for preschool children with developmental disabilities, who qualify for a center based preschool in the preschool special education program; and

- **WHEREAS**, a center based preschool program is an educational and therapeutic environment that provides instructional programming and support services to children with disabilities; and
- **WHEREAS**, the majority of center based preschool programs that service Delaware County children are located outside of Delaware County, far distances from the children they serve; and
- **WHEREAS**, preschool transportation is a specialized service falling under NYS DOT regulations and there are limited service providers in rural areas and children are transported from their home/child care location to a center based program up to 50 miles or greater from home; and
- **WHEREAS**, the current reimbursement rate for preschool transportation services in a rural county is \$39.03 per trip; and
- **WHEREAS**, the biggest factor in determining transportation trip costs, is whether vehicle capacity can be maximized. Vehicle capacity can range from 1-5 children. In Delaware County, the capacity of children per vehicle rarely exceeds 3 children and it is not uncommon to have 1 child in a vehicle due to geography and preschool travel requirements, where a child resides, distance between children and the distance to the center based program.
- **WHEREAS,** current average trip cost per child varies from \$70.47 (vehicle at capacity of 5) to \$352.32 (single child in vehicle).
- **WHEREAS**, the structure of the Preschool Transportation rate methodology promotes inequitable service provisions for geographically large rural counties without public transportation options. The large distance between students and preschool programs decreases vehicle capacity while increasing the number of vehicles required to service all students; and
- **WHEREAS**, transportation costs and bid proposals continue to increase due to labor shortages, increased operational overhead, fuel prices, etc.; and
- **WHEREAS**, adjustments to transportation reimbursement rates do not align with increased transportation costs.
- **NOW, THEREFORE, BE IT RESOLVED** that the Delaware County Board of Supervisors call on the New York State Department of Education to consider reviewing the current preschool transportation reimbursement rates and advocate for an increased rate adjustment in rural areas where preschool aged children are required to travel long distances to receive the center-based services as required by their Individual Education Plans (IEPs).
