REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

APRIL 12, 2023

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, April 12, 2023 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mr. Valente, Mrs. Driscoll, and Mr. Davis.

Mr. Marshfield offered the invocation.

Mr. Hinkley led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous Board meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Mr. Gladstone offered the following resolution and moved its adoption:

RESOLUTION NO. 72

TITLE: 2023 BUDGET AMENDMENT ACCEPTANCE OF 2022 BULLETPROOF VEST PARTNERSHIP GRANT SHERIFF'S OFFICE

WHEREAS, Delaware County is the recipient of a grant awarded by the US Department of Justice and administered by the Bulletproof Vest Partnership ("BVP") in an amount not to exceed \$3,300.00; and

WHEREAS, the grant, to be administered by the Delaware County Sheriff's Office, was awarded for the specific purpose of reimbursing Delaware County 50% of the cost of purchasing Bullet Proof Vests at a price not to exceed \$3,300.00 during the period commencing on April 1, 2022 and ending on August 31, 2024, unless extended.

RESOLUTION NO. 73

TITLE: OCCUPANCY TAX DISBURSEMENT APPROVAL DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, Delaware County established a Hotel Occupancy Tax for the purpose of promoting the tourism industry in Delaware County; and

WHEREAS, the Law stipulates that revenues derived from the occupancy tax are to be allocated for the promotion and development of the tourism industry in Delaware County; and

WHEREAS, pursuant to the Law, Delaware County established and empowered the Tourism Advisory Board to solicit, review and recommend proposals for the use of the funds raised from the occupancy tax for the promotion and development of the tourism industry in Delaware County

WHEREAS, the Tourism Advisory Board reviewed the proposals submitted under the tourism promotion and development grant program, and has recommended 44 proposals totaling \$144,623 for approval and funding by the Delaware County Board of Supervisors to support the investment of over \$540,000 in Delaware County's tourism industry.

NOW, THEREFORE, BE IT RESOLVED that the Delaware County Board of Supervisors approves the recommendations of the Tourism Advisory Board regarding the Tourism Promotion & Development Grant Program projects to be funded through occupancy tax revenues in 2023.

The resolution was seconded by Mr. Merrill.

Mr. Kosier introduced Director of the Department of Economic Development Glenn Nealis, and asked he address the Board. Mr. Nealis explained that there is an annual round of grants which support the tourism industry. He furthered that this round of funding was made available to municipalities within five qualifying categories. The Tourism Advisory Board reviews the proposed applications every year, their most recent meeting having occurred at the end of last month. The approved proposals total \$144,623.00 for forty-four proposals. He noted there are other sources of funds for the various projects stemming from the entities themselves or other outside entities, which total over a half million dollars invested in the tourism industry.

In response to Mr. Taggart, Mr. Nealis confirmed that the occupancy tax is in part collected from Airbnbs but the proportion of tax which stems from those businesses is not known. He further explained that Resolution No. 73 approves the Tourism Advisory Board recommendations, and Resolution No. 74 would permit the transfer of funds from the reserve

account to make it available for use.

In response to Mr. Taggart, Mr. Nealis agreed that some of these funds could be considered to mitigate any possible expenses or legal costs which are imposed upon the towns by Airbnbs.

Mr. Marshfield stated that the Town of Hamden is considering instituting an annual renewal fee for transient businesses of this nature to put towards expenses incurred by the town associated with such businesses. Mr. Nealis concurred that one of the reasons they track who is doing short-term rentals is to enable the towns to be able to perform fire inspections on these locations which typically incurs a fee.

The resolution was unanimously adopted.

Mr. Kosier offered the following resolution and moved its adoption:

TITLE: 2023 BUDGET AMENDMENT TRANSFER OF FUNDS DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, the revenues received under the Hotel Occupancy Tax during 2022 were set aside and placed into the Restricted Fund Balance (Hotel Occupancy Tax) for the purpose of the promotion and development of the tourism industry in Delaware County; and

WHEREAS, by Resolution No. 73 of 2023 the Board of Supervisors approved the list of tourism promotion and development grant projects to be funded through Hotel Occupancy Tax revenues and the funding of the approved contracts requires such revenues to be transferred from the restricted fund balance.

RESOLUTION NO. 78

TITLE: SIGNING OF BONDS AND NOTES FOR DELAWARE COUNTY TREASURER

WHEREAS, the Delaware County Treasurer and the Deputy Treasurer, are currently the only signatories able to sign on behalf of Delaware County on matters falling under the auspices of the Delaware County Treasurer's Office; and

WHEREAS, at times, due to illness or other circumstances, it would be beneficial to the flow of county business and when time is of the essence, to have a third person designated to sign on behalf of the County.

NOW, THEREFORE, BE IT RESOLVED that during said times when neither the Treasurer nor the Deputy Treasurer are able, for whatever reason, to sign on behalf of the County, the Board authorizes the Chairperson of the Board to sign any and all documents required to be signed by the Treasurer or Deputy Treasurer.

The resolution was seconded by Mr. Taggart and Mr. Marshfield and unanimously adopted.

Mr. Merrill offered the following resolution and moved its adoption:

RESOLUTION NO. 79

TITLE: LEGISLATIVE REQUEST FOR CONTINUATION OF SALES TAX LEVY AMENDMENT TO RESOLUTION NO. 49 OF 2023

WHEREAS, the Delaware County Board of Supervisors requested the New York State Legislature to extend an increase in the sales tax levy in January of 2020; and

WHEREAS, the New York State Legislature amended the law to allow for the collection of a sales tax at a rate which is one percent additional to the statutory three percent rate authorized by law; and

WHEREAS, current authorization to collect the additional one percent sales tax expires on November 30, 2023; and

WHEREAS, the Board of Supervisors passed Resolution No. 49 of 2023 on February 22 to formally request from the New State Legislature approval to continue with the additional tax every three years; and

WHEREAS, on March 22, 2023, County Administrators, Board Clerks, and Finance Officers were informed that an all-county extender would not be included in this year's budget and county members were advised to amend their requests for individual home rule sales tax extender of the additional tax for a two-year period being hereby amended; and

WHEREAS, a continuation of the additional one percent sales tax levy was requested by the Board and approved by Chapter 314 of the Laws of 2020; and

WHEREAS, the Board believes it appropriate to use the sales tax as a means to help stabilize the county property tax levy.

NOW, THEREFORE, BE IT RESOLVED that the Delaware County Board of Supervisors formally request that the New York State Legislature amend Section 1210 of the Tax Law to allow Delaware County to continue the collection of the additional one percent sales tax consistent with state approvals in 2005, 2007, 2009, 2011, 2013, 2015, 2017 and 2020.

The resolution was seconded by Mr. Marshfield.

Mr. Merrill stated that this extension of the increase in the sales tax levy was approved in a previous meeting this year, however, the state has now stipulated this must be for a span of two years instead of three.

The resolution was unanimously adopted.

WHEREAS, former Town of Davenport Supervisor Dennis J. Valente passed away on April 4, 2023; and
