REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

APRIL 26, 2023

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, April 26, 2023 at 1:02 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Vice Chairman Mark Tuthill presiding.

The Clerk called the roll and all Supervisors were present except Ms. Molé, Mr. Axtell, Mr. Hinkley, and Mr. Layton. Mrs. Driscoll arrived shortly after roll call.

Mr. Marshfield offered the invocation.

Mr. Wilson led the Board in the Pledge of Allegiance to the Flag.

Vice Chairman Tuthill introduced Supervisor Patricia Valente of the Town of Davenport. He stated that she has filled the vacancy left by her late husband Dennis Valente, and welcomed her.

The minutes of the previous Board meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Vice Chairman Tuthill granted privilege of the floor to Supervisor Taggart who introduced Director of Planning Shelly Johnson-Bennett.

Mrs. Johnson-Bennett introduced Captain Kevin Richard, Sergeant First Class Donat Thiebault, and Staff Sergeant Nerim Kuqi. She announced the final meeting regarding preparations for the Innovative Readiness Training (IRT) is occurring this week, and a few participating members of the military have been present to assist.

Captain Richard stated that he will be the Officer in charge of the Healthy Delaware IRT Mission which is to take place at the Walton Central High School this summer. He added that Staff Sergeant Kuqi will be the non-commissioned Officer in charge, as well as Sergeant First Class Thiebault who will be the Public Affairs Liaison. He explained that they will be bringing approximately one hundred soldiers including some from the Navy. Services provided will include general medicine, dentistry, optometry, and veterinary. The goal this week is to finalize planning with Mrs. Johnson-Bennett and other partners so when they arrive in July they can proceed with seeing patients immediately. Military presence will be from July 10 through 21, with a soft start of services beginning on July 11 and operational dates will be from July 12 through 19.

In response to Mr. Taggart, Captain Richard stated that the hours of operation will be

finalized today, but they anticipate the hours of 8:00 a.m. to 4:00 p.m. with at least two extended time hours until 7:00 p.m.

In response to Mr. Kosier, Captain Richard confirmed that it will be a walk-in situation; there will be a check-in area which will have basic medical screening, after which patients will be sent to a specific service area. The veterinary services will be provided in a separate area than human medical services.

In response to Mr. Cetta, Captain Richard stated he is waiting on a few individuals' credentials to be finalized but has had no issues.

In response to Mr. Vernold, Captain Richard confirmed that the event is open to everyone. Follow-up care has also been arranged for patients who need continued services, and there will be tents at the event with community partners for individuals to be able to facilitate their continued care.

In response to Mr. Davis, Captain Richard indicated that though there will be a sign-in, personal identification is not required to be presented. He agreed with Mr. Davis that bringing any past medical or dental records would be a good idea to assist providers, though is also not required.

In response to Mrs. Valente, Captain Richard explained that mental health providers will be focusing on the initial intake process due to how short of a period the event will be taking place. The patients will be referred to community partner providers for follow-up care.

In response to Mr. Taggart, Mrs. Johnson-Bennett confirmed that the event is open to anyone regardless of their residency. She stated that funding comes in part from Southern Tier 8, which includes seven other counties as well as Delaware County. Though the goal is to focus on Delaware County residents as it is a 'Healthy Delaware' mission and advertising will be focused in Delaware County, anyone is welcome at the event and no one will be turned away based on residency.

In response to Mr. Tuthill, Captain Richard indicated that any publications or advertisements must be approved by the Public Affairs military personnel. He explained that though Sergeant First Class Thiebault is the Public Affairs Liaison for this event but he is not a Public Affairs individual in the military, so any public outreach must be approved through a higher tier of the military.

Mrs. Johnson-Bennet further explained that Jessica Vecchione of Vecc Videography will also be meeting with the military Public Affairs personnel to have guidance regarding management of public outreach through social media. The goal at today's meeting is to streamline the advertising so outreach can commence as soon as possible; there are only about two months left before the event is to be held.

In response to Mr. Gladstone, Captain Richard stated that the 4:00 p.m. end time is for acceptance of new incoming patients for the day and not a succession of care for those who are

already checked in or receiving services. Patients who are already in the waiting area or already receiving care will continue to be served.

Vice Chairman Tuthill thanked Captain Richard, Sergeant First Class Thiebault, and Staff Sergeant Kuqi for their service and stated that everyone is looking forward to the event in July.

In response to Mr. Tuthill, Captain Richard thanked the Board for their time and the invitation to speak. He welcomed any further questions that may come up and expressed his excitement at being able to participate in the upcoming event.

Vice Chairman Tuthill stated that the Election Commissioners had announced they are hosting an open house after the meeting, inviting everyone to their new location at 97 Main Street. Refreshments will be served.

Mr. Marshfield asked if any of the other Supervisors were aware of what committee would address the Centralized Arraignment Part (CAP)? Would it be the Legislative Committee or Public Safety Committee?

In response to Mr. Marshfield, Mr. Tuthill indicated that he believes Chairman Molé intended CAP to go through the Public Safety Committee, and that upon her return the question could be clarified. Mr. Marshfield stated he knew some judges who were interested in assisting facilitate it.

In response to Mr. Tuthill, Sheriff DuMond reiterated that CAP is an acronym for Centralized Arraignment Part. He furthered that the goal is to establish a centralized arraignment point at the Public Safety Building in Delhi so that courts are more open and available to law enforcement, the Public Defender's Office, and prosecutors for arraignment purposes. He explained the way the current system works, during off hours a local judge with jurisdiction must be called out, as well as the Prosecutor and a defense attorney. Because of new legislation requirement of the participation of the Public Defender's Office the current process has become cumbersome, and as a result the State has come up with the CAP which will allow for anyone held on an arraignable offense would be held overnight at the corrections facility until normal court hours the next morning to be arraigned.

Sheriff DuMond further said that they have met with the Delaware County Magistrates Association, and the Chairman was present for the meeting. The Public Defender and District

Attorney were both in support of the change, and he believes a resolution will be forthcoming as soon as the next Board meeting. The consensus of all involved seems to be supportive of CAP. It is expected to make the process more efficient and ensure that every defendant has the proper representation.

In response to Mr. Kosier, Sheriff DuMond stated that judges will be assigned in a rotational fashion with back-up judges in the case of emergency if the primary judge is unable to fulfill the duty, an example of which would be inclement weather causing a judge who is a distance away from being able to safely travel. In discussion with Sheriffs in other counties where this process has been instituted, the conclusion is that the result has been a significant improvement in the operations of the arraignment process. A place has been identified in the lobby of the Corrections Facility to construct the CAP court location already, and its construction will be a simple process. A sample resolution from the Sixth Judicial District has been passed to Chairman Molé who forwarded it for introduction at the next Public Safety Committee meeting.

In response to Mr. Cetta, Sheriff DuMond indicated that whether someone is released on their own recognizance (ROR) depends entirely on if they are charged with an arraignable offense. Most offenses constitute being released on one's own recognizance; an offender would not see a judge before being released with an appearance ticket. Implementing the CAP would not change this process, the only time an arraignment is needed is if an arraignable offense has been committed, though there are not many of those left.

Mr. Ellis offered the following resolution and moved its adoption:

RESOLUTION NO. 90

TITLE: EXECUTIVE SESSION

BE IT RESOLVED that the Delaware County Board of Supervisors convene in executive session to discuss contract negotiations.

The resolution was seconded by Mr. Merrill and unanimously adopted.

The meeting reconvened in regular session with all Supervisors present except Ms. Molé, Mr. Axtell, Mr. Hinkley, and Mr. Layton.

Upon a motion, the meeting was adjourned at 2:02 p.m.
