#### **New Business**

IRT: Clinicians will rotate for the days the IRT is operational. If a person is in need for treatment they will be set up right than to be seen at the clinic.

Fair: we will be having an informational booth set up at the Delaware County Fair.

**Integrated License**: we are working on the work flow of the it would work, than we will have to turn our plan into the state. The Electronic Health Record System will also be the next big hurdle.

**Training**: Thank you for approving the ART training for the clinicians. The training will be here onsite at the clinic May 19- May 21.

We are looking at a suicide Assessment training for later this year

**Medical Staff**: staff is trained in MAT (Medical Assisted Treatment) we need to offer same day MAT services. Labs are a priority to be able to do this. We may be able to provide medical physicals down the road.

Lack of Psychiatric Beds in the state is an issue. CPEP/ERs are releasing clients seen due to no beds available. Local psychiatrists feel they need to be hospitalized but there are no beds. This is due to the closures of Psychiatric Hospitals in recent years.

Binghamton University: we are in touch with them to help with recruiting new social workers

We currently have 3 prescribers in house, we are fortunate compared to other counties where they have no prescribers in house.
