DELAWARE COUNTY BOARD OF SUPERVISORS

OCTOBER 25, 2023

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, October 25, 2023 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mrs. Driscoll and Mr. Hinkley.

Mr. Marshfield offered the invocation.

Mr. Axtell led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous Board meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

WHEREAS, a transfer from the Capital Road and Bridge Fund Balance is necessary.

NOW, THEREFORE, BE IT RESOLVED that the 2023 Budget be amended as follows:

In response to Mr. Marshfield, Mr. Haynes confirmed that six hundred thousand dollars of the three million dollars is from the Flood Buyout, and there had been some unexpected bridge design projects which are fundable. Mr. Haynes furthered that there had also been some projects which had commenced in 2022 and carried over into 2023.

RESOLUTION NO. 188

TITLE: OCCUPANCY TAX DISBURSEMENT APPROVAL DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, Delaware County established a Hotel Occupancy Tax for the purpose of promoting the tourism industry in Delaware County; and

WHEREAS, the law stipulates that revenues derived from the occupancy tax are to be allocated for the promotion and development of the tourism industry in Delaware County; and

WHEREAS, pursuant to the law, Delaware County established and empowered the Tourism Advisory Board to solicit, review and recommend proposals for the use of the funds raised from the occupancy tax for the promotion and development of the tourism industry in

Delaware County; and

WHEREAS, the Tourism Advisory Board reviewed the proposals submitted by the Tourism Promotion Agent (TPA) for Delaware County under the TPA grant program totaling \$104,498.00, and has recommended them for approval by the Delaware County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED that the Delaware County Board of Supervisors approves the recommendations of the Tourism Advisory Board regarding TPA projects to be funded through occupancy tax revenues in 2023.

The resolution was seconded by Mr. Merrill.

In response to Mr. Taggart, Director of Economic Development Glenn Nealis stated that these businesses are outside Delaware County, and are contracted to provide services. Granicus is the only entity that provides the service to identify active short-term rental establishments. The Brandman Agency proposal was selected two years ago in response to the County's RFP. They assist in broadening the reach of tourism advertising.

TITLE: SUPPORTING OPERATION GREEN LIGHT FOR ACTIVE MILITARY SERVICE MEMBERS IN TRANSITION TO CIVILIAN LIFE (VETERAN STATUS)

- **WHEREAS**, the residents of Delaware County have great respect, admiration, and the utmost gratitude for all of the men and women who have selflessly served their country and this community in the Armed Forces; and
- **WHEREAS**, the contributions and sacrifices of the men and women who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and
- **WHEREAS**, Delaware County seeks to honor these individuals who have paid the high price for freedom by placing themselves in harm's way for the good of all; and
- **WHEREAS,** New York State's Veteran population has decreased by 44% over the last 20 years; and
- **WHEREAS,** Veterans continue to serve their community in the American Legion, Veterans of Foreign Wars, church groups, and civil service; and
- **WHEREAS**, approximately 200,000 service members transition to civilian communities annually; and
- **WHEREAS,** an estimated 20% increase of service members will transition to civilian life in the near future; and
- **WHEREAS**, studies indicate that 44% to 72% of service members experience high levels of stress during transition from military to civilian life; and
- **WHEREAS**, active military service members transitioning from military service are at a high risk for suicide during their first year after military service; and
- **WHEREAS,** Delaware County appreciates the sacrifices our United States Military personnel made while defending freedom and believes specific recognition be accorded them in appreciation of their service and to demonstrate the honor and support they have earned.
- **NOW, THEREFORE, BE IT RESOLVED** with designation as a Green Light for Military Service County, the Delaware County Board of Supervisors hereby declares from October through Veterans Day, November 11, 2023 a time to salute and honor the service and sacrifice of our men and women in uniform transitioning from Active Service; and
- **BE IT FURTHER RESOLVED** that in observance of Operation Green Light, the Delaware County Board of Supervisors encourages its citizens in patriotic tradition to recognize the importance of honoring all those who the immeasurable sacrifices helped to preserve

freedom by displaying a green light in a window of their place of business or residence.

Mr. Vernold explained that having a green light illuminate houses and businesses from October through Veterans Day, November 11 shows support for the sacrifices of our men and women transitioning from active military service.
