REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

NOVEMBER 8, 2023

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, November 8, 2023 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mrs. Scott.

Mr. Marshfield offered the invocation.

Mr. Taggart led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous Board meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Mr. Gladstone offered the following resolution and moved its adoption:

RESOLUTION NO. 198

TITLE: 2023 BUDGET AMENDMENT NEW YORK STATE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES GRANT DEPARTMENT OF EMERGENCY SERVICES

WHEREAS, Delaware County has been awarded grant funding under the State Homeland Security Program from the New York State Division of Homeland Security and Emergency Services (WM2023 SHSP); and

WHEREAS, this grant was awarded in the amount of \$85,356.00 for the purpose of purchasing Computer Aided Dispatch equipment and related items.

NOW, THEREFORE, BE IT RESOLVED that the Department of Emergency Services be authorized to accept this grand funding as described above and that the 2023 Budget be amended as follows:

TITLE: 2023 BUDGET AMENDMENT TRANSFER OF FUNDS DEPARTMENT OF PUBLIC WORKS

WHEREAS, there are excess funds in the personal services line of the Machinery Fund due to several vacancies; and

WHEREAS, the Department has been instructed by the Finance Committee to transfer those funds to the equipment line and purchase equipment scheduled to be purchased in 2024 in an effort to reduce the 2024 Budget.

NOW, THEREFORE, BE IT RESOLVED that the 2023 Budget be amended as follows:

TITLE: EXCEPTION TO RESOLUTION NO. 269-1990 DEPARTMENT OF EMERGENCY SERVICES

WHEREAS, Resolution No. 269-1990 prohibited County employees from holding more than one County position simultaneously except if such dual employment is specifically authorized by resolution of the Board of Supervisors; and

WHEREAS, the Emergency Services office, at times, experiences difficulties in filling all open dispatcher shifts; and

WHEREAS, from time to time employees in other County Departments are willing to work on a per-hour, as-needed basis in the Emergency Services Department.

NOW, THEREFORE, BE IT RESOLVED that Resolution No. 269 is hereby temporarily waived until December 31, 2024, for County employees who are willing to work on a per-hour, as-needed basis in the Emergency Services Department.

The resolution was seconded by Mr. Ellis and unanimously adopted.

Mr. Ellis offered the following resolution and moved its adoption:

RESOLUTION NO. 202

TITLE: EXCEPTION TO RESOLUTION NO. 269-1990 PERSONNEL OFFICE

WHEREAS, Resolution No. 269 of 1990 prohibited County employees from holding more than one County position simultaneously except if such dual employment is specifically authorized by resolution of the Board of Supervisors; and

WHEREAS, the Personnel Office is experiencing difficulties in recruiting Clerks to serve as exam monitors for exams scheduled on Saturdays and to help with additional clerical duties as necessary; and

WHEREAS, from time to time employees in other county departments may be willing to work on a per-hour, as-needed basis.

NOW, THEREFORE, BE IT RESOLVED that Resolution No. 269 of 1990 is hereby temporarily waived until December 31, 2024, for County employees who are willing to work on a per-hour, as-needed basis in the Personnel Office.

The resolution was seconded by Mr. Merrill and unanimously adopted.

Budget Director Art Merrill presented the Tentative 2024 Budget. He also explained that some open positions were unfunded to keep the budget below the tax cap. These positions were not eliminated, only unfunded until they are filled. He furthered that the 2024 Tax Levy is \$34,214,845.00 which is an increase of 1.9075% from 2023. In response to the thanks expressed by the Board for everyone's hard work, Mr. Merrill shared his appreciation again for the time and effort taken by all who were involved.
