REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

MARCH 13, 2024

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, March 13, 2024 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present.

Mr. Marshfield offered the invocation.

Mr. Faulkner led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous Board meeting and Public were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Mr. Gladstone provided an update on the location of the Cornell Cooperative Extension Board meeting scheduled at 6:00 p.m., stating that it will be held at the Walton Central High School instead of Hamden to accommodate the anticipated number of attendees. He furthered that there is a Zoom link available as well, and stated he will forward the link to the Clerk of the Board to distribute to Supervisors.

RESOLUTION NO. 39

TITLE: 2023 BUDGET AMENDMENT TRANSFER OF FUNDS LEGAL AID TO INDIGENTS

WHEREAS, the New York State Office of Indigent Legal Services (ILS) increased 18-B assigned counsel rates effective April 1, 2023; and

WHEREAS, assigned counsel rates were budgeted at \$60.00 per hour for misdemeanor cases and \$75.00 per hour for felony cases in the 2023 Budget; and

WHEREAS, NYS ILS increased the assigned counsel rate for both crimes to \$158.00 per hour; and

WHEREAS, ILS has provided for partial reimbursement for increased costs due to the rate change; and

WHEREAS, the Public Defender's Office has submitted requests for reimbursement for the second, third and fourth quarters of 2023; and

WHEREAS, ILS approved the fourth quarter reimbursement in the amount of \$53,471.11 while still reviewing the second and third quarter requests; and

WHEREAS, the County received the fourth quarter reimbursement on March 4, 2024.

- Delaware County Jail to hire a per diem MH/SUD medication treatment provider: \$36,900.00
- Delaware County Jail to hire a per diem License Mental Health Professional for after hours for risk and monitoring status of inmates.: \$7,915.20
