Proposal Number Two, a Question

Shall a Local Law entitled "A Local Law to Reduce the Number of Assessors in the Town of Davenport from Three (3) Elected Assessors to One (1) Appointed Assessor in the Town of Davenport, New York" be approved, whereby the board of three elected assessors be abolished and one appointed assessor position created for an initial term, if adopted, to take effect January 1, 2026 to September 30, 2026, and whereby a six (6) year appointment term will commence on October 1, 2026.
