## NOTICE: ONLY APPLICATIONS SUBMITTED TO THE DELAWARE COUNTY PERSONNEL OFFICE WILL BE CONSIDERED FOR THIS EXAMINATION.

**EXAMINATION FEE:** A fee of \$15.00 is required for each separately numbered examination for which you apply. The required fee MUST accompany your application and be in our office by 4:30pm on the last filing date or you will not be approved to take the examination. Send or deliver your certified check or money order payable to the Delaware County Personnel Office. Write the examination number(s) on your check or money order. **\*\*\*\*PERSONAL CHECKS WILL NOT BE ACCEPTED.\*\*\*\*** <u>No refund of fees will be allowed whether or not you meet the minimum qualifications.</u> You are urged to compare your qualifications carefully with the requirements for admission and file only for those examinations for which you are clearly qualified.

**EXAMINATION FEE WAIVER:** A waiver of examination fee will be allowed if you are unemployed and primarily responsible for the support of a household. In addition, a waiver of examination fee will be allowed if you are determined eligible for Medicaid, or receiving Supplemental Security Income payments, or Public Assistance (Temporary Assistance for Needy Families/Family Assistance or Safety Net Assistance) or are certified Job Training Partnership Act/Workforce Investment Act eligible through a State or local social service agency. All claims for examination fee waiver are subject to verification. If you can verify eligibility for examination fee waiver, complete a "Request for Examination Fee Waiver and Certification" form and submit it with your application by the Last Filing Date as listed on the Examination Announcement. "Request for Examination Fee Waiver and Certification Fee Waiver and Certification." and then "personnel." Waivers will not be considered if filed after the last filing date.

**LOCATION OF POSITIONS:** Positions may become available at schools and the Board of Cooperative Educational Services under the jurisdiction of Delaware County Personnel.

**ELIGIBLE LISTS**: Successful candidates will have their name placed on the continuous Eligible List for one year. After one year, candidates' names will be removed from the list. Candidates may apply for retest at six-month intervals.

**SALARY:** Salary varies depending on location of the position.

**<u>DUTIES</u>**: This is a professional position involving responsibility for evaluating, planning and providing physical therapy treatment in accordance with written prescription or referral from a physician who provides medical direction. Supervision may be exercised over the work of Physical Therapy Assistants, Physical Therapy Aides and clerical employees assigned to the service. The work is performed under the general supervision of an Administrator. Does related work as required.

MINIMUM QUALIFICATIONS: Licensed and currently registered by the New York State Education Department as a Physical Therapist.

**<u>NOTE</u>**: Possession of a valid New York State driver's license may be required at time of appointment and maintained during employment.

**SPECIAL REQUIREMENT FOR APPOINTMENT IN SCHOOL DISTRICTS:** In accordance with the Safe Schools Against Violence in Education (SAVE) legislation, Chapter 180 of the Laws of 2000, and by the Regulations of the Commissioner of Education, candidates for appointment in school districts must obtain clearance for employment from the State Education Department prior to employment based upon a fingerprint and criminal history background check.

There are no residency requirements for this exam, however, preference in appointment may be given to legal residents of Delaware County, or the school districts, towns, villages, special districts, or Delaware County departments where the vacancies occur.

**SUBJECT OF EXAMINATION:** Candidates' applications will be rated on the basis of their training and experience in relation to the requirements of the position. Since there is **NO WRITTEN OR ORAL TEST** for these positions, it is essential that candidates give complete and accurate information on their applications. Permanency after appointment will be based on successful completion of a probationary period during which performance and work habits will be evaluated.

This examination is being prepared and rated in accordance with Section23(2) of the Civil Service Law. The provisions of the New York State Civil Service Law, Rules, and Regulations dealing with the preparation and rating of examinations, as well as establishment and certification of eligible lists for positions in the classified service will apply to this examination.

RESUMES WILL <u>NOT</u> BE ACCEPTED AS A SUBSTITUTE FOR YOUR APPLICATION <b>BUT WILL BE ACCEPTED ONLY AS AN ADDITION TO YOUR APPLICATION.** A separate application must be filed for <u>EACH</u> examination for which you apply. Applications must contain the correct examination title and/or number in order to be considered. The Delaware County Personnel Office reserves the right to accept or to reject applications/fees submitted/postmarked after the last announced filing date. The Delaware County Personnel Office is NOT responsible for lost or misdirected mail.

\*\*\*Veterans or Disabled Veterans:\*\*\* Who are eligible for additional credit must submit an application for veteran's credit with their application for examination or at any time between the dates of their application for examination and the date of the establishment of the resulting eligible list. Applications for veteran's credit are available from this office. Veteran's credits can only be added to a passing score. Effective January 1, 1998, the State Constitution was amended to permit a candidate **currently in the armed forces** to apply for and be conditionally granted veteran's credit in examinations. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. <u>No credit may</u> be granted after the establishment of the list. It's the responsibility of the candidate to provide appropriate proof, as defined in Section 85 of the Civil Service Law, that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credits.

**\*\*\*Children of Firefighters and Police Officers Killed in the Line of Duty\*\*\***In conformance with section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
