On November 4th, 2020, the Delaware County Board of Supervisors' Chairwoman Tina Mole convened the first Delaware County Police Reform and Reinvention Collaborative committee meeting. At Chairwoman Mole's direction, the initial committee meeting was facilitated by Delaware County Sheriff Craig DuMond to provide the Committee with an introduction to the Sheriff's Office as well as an overview of current operations and general statistics.

The Committee was formed in response to Governor Cuomo's 2020 New York State Executive Order 203 which requires each chief executive officer of the local government to convene the head of the local police agency and stakeholders in the community to develop a plan that reviews and is tailored to the specific needs of the community which fosters and improves community and police relationships.
