**Census**: Mental Health/Drug and Alcohol is currently seeing 742 clients. AOT- 2

**Visits**: in 2022 Mental Health and Drug and Alcohol have seen 10,116 visits, in 2023 Mental Health and Drug and Alcohol have seen 10,546 \* this is an estimated number.

**Handicap Accessibility**: The window for our next OMH audit begins in July and the building is not fully ADA Accessible. There are doors that need to be automatic to meet ADA standards. Joe will take the lead to see what needs to be done to be contracted out.

#### **New Business**

**Jail Services:** We have resumed in person jail services for Mental Health and our Forensic Counselor is going to the jail approximately 10 hours/week, almost every weekday. She provides supportive counseling and risk assessment to clear inmates off constant watch. ADAS provides approximately 6 hours/week for jail services.

**NYS DOH**: is offering grants totaling 250 million dollars, for capital projects such as our new electronic health record including patient portal or building updates. Doug is going to pursue applying for these funds. The Behavioral Health building is paid for in full, Art suggested we look into the future to see what we might need before the funds dry up.

**Integrated License**: Part of the integrated licensing is not just combining OMH & OASAS but also DOH with providing annual physicals. For this clinic to perform physical exams there will need to be some updates to the medical suite. Doug and Sara will follow up with what changes need to happen.

**Narcan Training**: All staff will be participating in this free training. We are also looking into becoming an Opioid Overdose Prevention program so we can order Narcan kits in bulk as needed. OMH and OASAS require that we provide educational material and Narcan to any person that is using, or has household member that are using, Opioids.

**Disaster Mental Health Training (MHDRT).** OMH will be providing training including "train the trainer" with focus on supporting Mental Health during a crisis. OMH is looking for a team of 20-25 licensed and unlicensed individuals to receive training to provide direct support during disasters, and to develop trainers to support future training. Doug is contacting Steve Hood at emergency services and will also be contacting local fire departments. OMH has already started a new program where they call any time there is bad weather in the area to make sure we are able to handle everything.

Community Outreach: We are looking to do community events in May to celebrate May is Mental Health Month, and in September for Suicide Awareness Month. We would like to hold the events at the Behavioral Health Facility, including opportunities for tabling to provide materials and information highlighting available services within DCBHS and other community agencies. We are also exploring having a food truck or two here for the event. Joe also mentioned having a community open house during that time.
