Updates

<u>Security/Safety</u> – Phones can be used for "panic buttons" the call would go directly to supervising staff. IT would like to have staff sign off that they have received training of when to use the button or when to call 911.

<u>Sidney Satellite</u> – Doug and Sara met Eric Wilson, Sidney Town Supervisor a few weeks ago to check out a different space at Tri-Town Hospital. They will be changing the space into 2 offices and 1 conference room; a lease should be generated this week. Rent will be around \$800 per month.

730-Restoration – Both expire this year, July and October. Doug will be calling his contact monthly to get an update. Counties are trying to change legislation to put a time limit of 90 days on being restored, as counties cannot afford to pay these amounts.

New Business

Jail Based Services – Currently updating the existing MOU for Mental Health Forensic Social Worker services. Consulting and generating an MOU for the jail for Substance Use and for psychiatric prescriber contracts. The jail has been searching for psychiatric services for several years, this MOU would be for prescriber consultation not prescribing medications and a as needed basis for any inmates that may need. The psychiatrist would either speak provider to provider or the inmate would be brought down to the clinic for a consult. Any psychiatrist services will be billable with re-imbursement through the jail. With the new MOU's the clinic hopes to increase group work at the jail for both Mental Health and Substance Use services.

Methadone Treatment – OASAS reported that 54 individuals from Delaware County travel to other parts of the state to receive treatment; Methadone must be given daily. OASAS would like to see treatment within Delaware County; the clinic cannot provide this service. The LGU supports a Mobile Methadone unit that would be able to travel throughout the county.

<u>Transportation Committee</u> – Initiated by Keath Weaver at DSS, Doug as well as Office of the Aging, Veterans Services and Delaware Opportunities will be meeting Wednesday, March 19th in Delhi to discuss ideas. Doug has a meeting scheduled with Teresa Finch, owner/operator of TMR Transportation, to explore a contract for on-call services. Doug will also reach out to Jayne Francisco with RSS about the TOPS transportation program.

<u>Disaster Mental Health Planning</u> – On March 11th, Doug met with the representatives from OMH DMH, Steve Hood (EMS), Mandy Walsh (Public Health) and Schoharie County EMS Director, MCAT staff and Chenango, Otsego & Schoharie County Directors of Community Services. Doug will review the current Delaware County plan and consult with Steve Hood. The committee will develop a cross- county plan to include an MOU; the plan must be submitted to OMH before the end of 2025.

Staff Development

<u>IMA EHR</u> – Will be down the week of 3/31-4/4 to start the next phase of integration of the MH & SUD records.
