Preventing Substance Abuse



- The Substance Use Prevention Program is granted funded by New York State OD2A (Overdose To Action). The goal for this grant is to reduce substance use and educate communities.
- Delaware County Public Health collaborated with law enforcement, hospitals, and treatment and prevention agencies to provide education to the community. Topics included substance use, harm reduction resources, and prevention of substance use.
- Substance use data was collected from Tri-Town Emergency Department and the three hospitals in Delaware County, EMS, Fire Departments and Delaware County Correctional Facility.
- 500 harm reduction kits were assembled and distributed to hospitals, pharmacies, Delaware County Correctional Facility, Delaware Opportunities food bank and FOR-DO.
- An exhibit on harm reduction was featured in Cornell Cooperative Extension's Human Ecology building at the Delaware County Fair. The display was awarded 3rd place. Education was provided on harm reduction, resources, and county partner agencies. Harm reduction kits were dispersed. Staff from Friends of Recovery-Delaware Otsego also trained nine people on Naradministration.

# Promoting Mental Health



- December 2022; The Pocket Guide to Services and Emergency Contacts in Delaware County, NY was updated.
- October 2022; Suicide Prevention Network of Delaware County co-sponsored the 10th annual AFSP KSE Out of the Darkness Suicide Prevention Awareness WALK. Network members hosted a prevention resource table and were available to talk, offer support and provide community resources. A memorial service was held and speeches by community stakeholders stressed the importance of mental wellness. The WALK raised +\$10,000 for research and to support community-based prevention programs.
- August 2022; The Delaware County Office for the Aging held their annual senior picnic. The Suicide Prevention Network, National Alliance on Mental Illness, NAMI and Mobile Crisis Team, MCAT staff collaborated in hosting a mental health resource table at the event. A 988 display was created to raise awareness among seniors about the new 988 nationwide number for individuals experiencing suicidal thoughts, mental health and substance use emergencies or emotional distress. In an ongoing effort to reduce stigmas surrounding mental health, seniors were given the opportunity to learn about the importance of mental wellness in their lives and community resources. 988 crisis hotline and mental health resource materials were available to attendees.

### Communicable Disease Report

• A total of 5,769 communicable disease laboratory reports were received and investigated resulting in 1,257 cases being completed and reported for 2022.

### Sexually Transmitted Diseases (STD)

 Delaware County Public Health provides anonymous Human immunodeficiency virus (HIV) and other STD testing and treatment for Delaware County residents through contracted testing services provided by Family Planning of South Central New York. A total of 42 STD tests were conducted as part of Delaware County's STD clinic services.

### **Immunization Program**

- Public Health monthly immunization clinics continue to offer no-cost or low-cost vaccines for uninsured and underinsured individuals through participation with the New York State Department of Health Vaccine for Children's Program and Vaccine for Adults Program.
- Immunization grant staff resumed in person Immunization Quality Improvement for Provider (IQIP) visits for pediatric providers. Visits promote and support implementation of provider-level strategies designed to help increase on-time vaccination of children and adolescents. Provider specific reports were gathered in New York State Immunization Information System (NYSIIS), prior to visits, to identify strengths or improvement opportunities within each site. Throughout the year, follow-up visits provide an opportunity for additional partnership; the goal of these visits is to continue to assist each practice on their site-specific quality improvement strategies. Delaware County Public Health visited a total of 7 providers; 3 pediatric providers, 2 adult providers, 1 school, and 1 daycare.
- New York State Public Health Law requires all mothers to be tested for hepatitis B during pregnancy. Infants who are born to mothers who are infected with hepatitis B are at greater risk of acquiring infection during birth. Delaware County provides coordination to assure at-risk infants have received appropriate preventative treatment, vaccination, and testing to reduce their risks from exposure.

### **Immunization Program**

### **Monthly Vaccine Clinics**

- 60 vaccinations were given at Public Health's monthly immunization clinics.
- The agency held 3 Monkey Pox Clinics; 18 total vaccinations were administered.

#### **COVID-19 Vaccine Clinics**

- Public Health, assisted by NYSDOH, conducted 21 clinics. 11 were held in the towns of Sidney, Hancock, and Stamford. A total of 596 individuals were vaccinated.
- Public Health conducted 21 Covid-19 vaccine clinics in 2022.
- Public Health clinics administered 766 Covid-19 vaccines in 2022.
- Public Health contracted with Ambulanz to vaccinate 21 homebound residents.





### **Rabies Program**

- A total of 295 bite reports were received in 2022.
- There were a total of 242 animal to human bite reports in 2022.
- In 2022, a total of 1,039 dogs, cats, and ferrets received rabies vaccinations at the 9 free public clinics.
- A total of 23 individuals were referred for post exposure treatment.
- A total of 30 animals were sent for rabies testing with 1 animal testing positive for rabies.

### Emergency Preparedness & Response

- Staff training was continuously available during 2022; training opportunities included National Incident Management System (NIMS) training, HSEEP, disease control and surveillance, communication management, outbreak management, access to functional needs, psychological first aid, and mass vaccination point of distribution training,
- Drills including volunteer management (ServNY), requesting needed resources from New York State Department of Health (MERITS), Point of Distribution site activation, and mass electronic communication events Integrated Health Alerting and Notification System (IHANS) were conducted to test the capabilities of the DCPH staff's ability to respond during an emergency event and identify any potential gaps.
- Ebola preparedness continued throughout 2022, staff conducted PPE donning and doffing drills. Drilling ensured a continuous effort of skills building for staff and community partners.
- Delaware County was selected by New York State Department of Health (NYSDOH) to receive extra assistance in the administration of COVID-19 vaccinations throughout the County. NYSDOH provided vaccine and staffing; including members of the National Guard, vaccinators, data entry/registration, a pharmacist, and a nurse practitioner. Public Health Programs Manager coordinated, and managed the clinics at the Sidney Elks Club, Catskill Vet Outreach Center, Stamford, and Hancock Central School Bus Garage. COVID-19 vaccinations, and boosters were offered to all eligible individuals. Eleven clinics were conducted, and 596 vaccinations were administered.
- Public Health participated in the New York State Department of Health's (NYSDOH) ongoing Local Health Department (LHD) Performance Incentive Program. The LHD experience in responding to the COVID-19 pandemic became the focus for the 2021-2022 Year Ten LHD Performance Incentive Program.





# **Injury Control**

#### **Lead Poisoning Prevention**

- The Lead Poisoning Prevention Program is funded by NYSDOH
- Case management was provided to children and their families with elevated BLL of 5ug/dL or greater. Communication with these individuals was conducted by phone, mail, and in person.
- 16 children were identified with an elevated lead level.
- 40 cleaning kits were distributed to families. Kits included cleaning tools; in addition, education was provided on the prevention and reduction of lead poisoning.
  - 10 cleaning kits were provided to the Walton foodbank. The Town of Walton had the highest number of lead cases.
  - 10 cleaning kits were provided to a centrally located food bank at Delaware Opportunities.
  - 20 cleaning kits and lead poisoning prevention education was distributed to the community at Fair on the Square in Delhi.
- An in-service was provided for employees at Delaware Opportunities. Employees were educated on common sources of lead, side effects of contamination, ways to prevent poisoning, and how to assist families that have a child(ren) with elevated lead levels.

# Injury Control

#### **Child Passenger Seat Program**

- The Child Passenger Safety Program coordinated by The New York State Governor's Traffic Safety Committee provides grant funding for Certified Child Passenger Safety Technicians to train the public on correct installation and use of their child's safety seat or booster seat. Seats are checked for proper fit for the size of the child. Technicians are also able to determine whether a seat has been recalled or exceeded its viable lifetime.
- If car seat technicians are unable to safely install a car seat owned by a family, a new car seat is provided at no cost to families.
- Public Health also contracts with Delaware Opportunities to provide car seats to low-income families; monthly fitting stations are also available at the Delaware Opportunities office in Hamden NY.
- Three staff members became newly certified as technicians; seven total staff members are certified technicians.
- Car seat distribution in 2022 for the fitting station, low-income program, and community events was 235 seats.

  - Delaware County may not receive cause of death information for every resident who becomes deceased outside of county.

# Family Health

### Children and Youth with Special Health Care Needs

- Children and Youth with Special Health Care Needs is grant funded by NYSDOH. This program provides support to children who are from birth to 21; children are diagnosed with a serious or chronic medical condition.
- Outreach was provided through social media platforms, phone, email and radio.
- Three children received orthodontia services.
- The Children and Youth with Special Health Care Needs Program sponsored events held at O.W.L (Oneonta World of Learning). These programs promoted play, development, and learning among 114 children that live in Delaware County.
- A speaking event was held in June at SUNY Delhi College; the guest speaker was Mary Muscari, PhD, MSCr, CPNP, PMHCNS-BC, AFN-BC. Mary spoke about children and emerging adults with special health care needs as victims and perpetrators of violence. Topics included effects of violence and violence exposure, special needs of victims with disabilities, and special needs of children/youths with disabilities who commit delinquent acts. This speaking event was open to the community, parents, providers, and professionals.



# Preschool Special Education Program

The Preschool Special Education Program provides special education services to children aged three to five years old, who have a disability that affects the way they learn. Eligibility for services is determined by the child's school district's Committee on Preschool Special Education (CPSE). The decision for services is determined by CPSE following part 200 of the New York State regulations of the Commissioner of Education. Services that are provided through the committee include evaluations, related services, special class integrated preschool programs (4410), special class programs, and transportation services. The CPSE creates an Individualized Education Program (IEP). IEP addresses the services the child may need to assist in the learning. Preschool children who receive an IEP in New York State are classified as a "Preschooler with a Disability".

#### **Related Services**

- Delaware County contracts with individual service providers for related services. Services are provided to eligible preschool children in preschool programs, day cares, and homes.
- Professional Related Services include: Speech and Language Pathologists, Speech Therapists, Occupational Therapists, and Physical Therapists.

#### State Approved Preschool Special Education Programs (4410 Programs)

New York State Education Department is the lead agency that oversees and approves agencies to operate a 4410 special education programs for preschool. These programs are able to provide evaluations, serve as related service providers, Special Itinerant Education Teachers (SEIT) services, integrated classrooms, and special classes for eligible preschool students.


#### **Transportation**

 Delaware County Public Health maintains contracts for transportation. The agency also contracts with VMC Consultants to determine transportation routing for transportation bid specifications and processing.




# Preschool Special Education Program

### Number of Preschool Children Receiving Services in Dleaware Co. 2020-2022




#### 2022 Preschool Related Services by Type

# Programs and Funding

- In 2022 Delaware County Public Health Services had expenses totaling \$4,661,002 and was able to secure funding totaling \$2,781,848 resulting in a net cost of \$1,879,154.
- Our Early Intervention and Preschool Special Education Programs received a total of \$1,384,471 through Medicaid, Private Insurance, New York State Department of Health and New York State Department of Education.
- The largest source of funding for local health departments is Article 6
  State Aid. In 2022 Delaware County Public Health Services received
  \$595,569 of funding through state aid to support the following core
  program areas:
  - Chronic Disease Prevention,
  - Communicable Disease Control,
  - Family Health,
  - Environmental Health,
  - Emergency Preparedness and Response,
  - Community Health Assessment.

The Public Health Corporate Compliance Program was developed to ensure standards of care, ethical behavior and compliance with all applicable federal, state and local laws and regulations governing the agency. Compliance Program policies and procedures are in place to identify and report fraud, waste, and abuse of public resources. The Agency's compliance program must meet requirements of NYS Social Services Law ("SSL") Section 363-d and 18 NYCRR Part 521. The compliance committee uses a team approach to ensure the identification, investigation and correction of compliance issues. The Compliance Committee met periodically to review and discuss potential compliance risks.

- Continued monitoring of providers within the KChecks system.
- Annual Corporate Compliance Training completed for Public Health staff, Health Services Advisory Board, and Board of Supervisors.



# Agency Summary

The was a year of recovery. The agency continued to conduct COVID clinics January – March. NYSDOH and CDC revised the Isolation and Quarantine guidance. In January 20022, New York State no longer required local health departments to conduct individual contact tracing, quarantine monitoring and case investigations. Public Health focused on larger case clusters and outbreaks in congregate settings.

New York State face mask requirements for the community, schools, public transportation and correctional facilities were lifted in September 2022. Mask requirements were still in effect for hospitals, nursing homes and long-term care facilities, congregate settings and those individuals recovering form COVID illness.

Day to day tracking and data reporting decreased and rolled over to the NYS COVID Dashboard reporting system. By late spring, the agency had resumed more typical day to day local health department work. The agency COVID-19 After Action Report was submitted to NYSDOH.

COVID-19 cases were still prominent in fall and winter 2022. Increases in influenza illness occurring in early November, were a nationwide phenomena as flu hospitalizations increased and cases continued to rise an remain high through December.

Community Health Assessment/Community Health Improvement Plan

Public Health collaborated with O'Connor Hospital, Delaware Valley Hospital – UHS, and Margaretville Memorial Hospital – Westchester Medical Center Health Network to complete the 2022-2024 Community Health Assessment. Data mining and regular meetings with hospitals and public health occurred from February to September. Online community and professional surveys were initiated from May through August. Hospital community service plans and the Delaware County Community Health Improvement Plan were developed and submitted to NYSDOH, with the Community Health Assessment in December.



# Agency Summary

#### Staffing

One per diem Nurse retired and our per diem Occupational Therapist left the agency in early 2022. Our Clerk left in February and our Administrative Assistant and one full-time Nurse resigned in April 2022. We hired a full-time LPN and Senior Account Clerk in April and May and an existing staff member was promoted to Administrative Assistant. In August, we hired a Senior Public Health Specialist through the NYS Public Health Fellowship grant. This individual is a contracted employee with NYS, working directly for Delaware County Public Health and paid via the PH Fellowship grant.

#### **Public Health Programs**

Substance use prevention activities included the continued collaboration with community partners, data collection, distribution of harm reduction kits and the harm reduction exhibit at the Delaware County Fair.

The Suicide Prevention Network updated the *Pocket Guide to Services and Emergency Contacts in Delaware County,* co-sponsored the annual AFSP KSE Out of the Darkness Suicide Prevention Walk and provided community outreach and education.

A total of 5,769 reportable communicable disease lab reports, resulting in 1,257 reportable cases. A total of 295 animal bite reports were received by the rabies program. Rabies vaccination was provided to 1,039 dogs, cats and ferrets.

The agency held 21 COVID-19 vaccination clinics, resulting in 766 vaccinations and coordinated with Ambulanz to provide covid vaccination to homebound individuals. Three Monkey Pox clinics were held in addition to the regular monthly immunization clinics.

# Agency Summary

The preparedness program focused on staff training related to emergencies, drills, local COVID-19 clinics conducted in cooperation with NYSDOH and the Year Ten Performance Incentive Program activity of responding to the COVID-19 pandemic. Staff participated in the newly formed Chenango, Otsego and Delaware VOAD (Voluntary Organizations Active in Disaster) Committee meetings.

Public Health staff provided a lead poisoning prevention in-service to Delaware Opportunities staff. Case management of children with elevated lead levels continued and cleaning kits were distributed to families and community members. Opportunities. Health guidance visits to new moms and babies resumed.

Seventy-four home visits were provided to new moms and babies. Children and Youth with Special Health Care Needs program sponsored a guest speaking event at SUNY Delhi for community members, parents and professionals, related to children and emerging adults with special needs as victims and perpetrators of violence

#### EI and Preschool

There were 90 children enrolled in the Early Intervention program. The agency's per diem occupational therapist left in early 2022. The provider shortage for speech, occupational therapy and physical therapy continues for both EI and the preschool special education program, with waitlists for services. Canvassing for a replacement speech language pathologist yielded no new applicants by the end of 2022. 136 children received preschool special education therapy services with 50 of those children attended center based preschool programs.
