- JB, The problem is the sewer plants are overfull too. They really don't want it either.
- JT, I don't know what Tyson's done. I don't know if we need someone there when we deliver or how that goes.
- JB, We don't have enough equipment to haul any longer anyhow.
- JC, But at different times if it was available would that help?
- JT, At certain times, but right now it probably would not.

The following is an update to the activities of the Safety Office from 5/29/2025 to 6/24/2025.

1. Accidents

3. Facilities

- Received PESH Notice of Violation and Order to Comply for PESH inspection in work zone on CR-14. Item 1 included employee flagging was standing in front of a vehicle and not visible to oncoming traffic. Item 2 included traffic control signs not deployed in accordance to Part 6 of the incorporated MUTCD. One lane road ahead sign not utilized. Item 1 has an abatement date of 8/14/2025. Item 2 was corrected during inspection.
- PESH conducted an investigation on 6/11/2025 at SWMC-Compost facility for fall incident.
 At this time the PESH investigator has indicated that no citations will be issued based on
 their findings. All requested information has been provided to PESH. Safety Officer
 should receive report within a few weeks.
- Annual hoist inspections were conducted by American Crane on 6/16/2025. One hoist was deemed out of service. Reports have been received and distributed.
- PFT's have been scheduled for Compost personnel for 7/16/2025.
- Bloodwork has been completed for both bridge crews in accordance with current medical protocol.
- Bloodborne pathogens and sharps handling policy and procedure training is being conducted with SWMC-Landfill personnel by the Safety Officer on 6/25/2025.
- In-house general vehicle maintenance training has been completed with one patrol remaining to complete training.
