REGULAR MEETING

DELAWARE COUNTY BOARD OF SUPERVISORS

APRIL 14, 2021

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, April 14, 2021 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman Tina B. Molé presiding.

The Clerk called the roll and all Supervisors were present except Mrs. Scott. Supervisor Pigford attended via Zoom.

- Mr. Marshfield offered the invocation.
- Mr. Eisel led the Board in the Pledge of Allegiance to the Flag.

The minutes of the previous meeting were accepted as presented.

The Clerk noted that all communications received have been referred to their respective committees for review.

Mr. Eisel offered the following resolution and moved its adoption:

RESOLUTION NO. 66

TITLE: DCJS GRANT FOR REIMBURSEMENT OF DISCOVERY COST TO LOCAL LAW ENFORCEMENT AGENCIES DISTRICT ATTORNEY

WHEREAS, the State of New York Division of Criminal Justice Services has awarded a grant to Delaware County to reimburse the cost of implementation of discovery reform requirements; and

WHEREAS, the grant is for those expenses that were incurred by law enforcement between April 1, 2020 and March 31, 2021 (Project ID No. DG20-1011-D00); and

WHEREAS, the completed purchase of equipment must occur prior to March 31, 2021 to be reimbursed; and

WHEREAS, this funding will provide for the purchase of computer equipment that is in need of replacement.

TITLE: OCCUPANCY TAX DISBURSEMENT APPROVAL DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, Local Law No. 13 of 2015 established a Hotel Occupancy Tax in Delaware County for the purpose of promoting the tourism industry in Delaware County; and

WHEREAS, the Law stipulates that revenues derived from the occupancy tax are to be allocated for the promotion and development of the tourism industry in Delaware County; and

WHEREAS, pursuant to the Law, Delaware County established and empowered the Tourism Advisory Board to solicit, review and recommend proposals for the use of the funds raised from the occupancy tax for the promotion and development of the tourism industry in Delaware County; and

WHEREAS, the Tourism Advisory Board reviewed the proposals submitted under the tourism promotion and development grant program and the tourism promotion agent grant program, and has recommended 45 proposals totaling \$335,460 for approval by the Delaware County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED that the Delaware County Board of Supervisors approves the recommendations of the Tourism Advisory Board regarding projects to be funded through occupancy tax revenues in 2021.

The resolution was seconded by Mr. Merrill.

Mr. Valente stated the amount is quite a bit higher than last year. The Tourism Advisory Board was able to satisfy a lot of grant applications and it doesn't look like it's going to go down anytime soon. The Board would like to encourage not-for-profit and tourism-related businesses to apply for next year's money because they were able to satisfy most of the grants that were requested.

Mr. Marshfield noted the brochure on each Supervisor's desk that the Town of Hamden developed for which half of the cost to make this brochure came through this occupancy tax money. Mr. Marshfield thanked Ms. Vecchione for her help and stated the brochure layout was done by Silver Top Graphics in New Kingston and the printing was done by Locust Grove printing in Arkville so they kept the work local and spread the money around which double folds everything. Ms. Vecchione made some videos for the town that were put on their website which was also part of this package. He said they are thankful they got the grant from the occupancy tax and they were able to match it with another grant.

Mr. Merrill stated that was exactly what they were trying to do with the funds they received.

Mr. Taggart observed that awards have gone up from the first year.

Mr. Valente stated they anticipated a quarter of a million is where this would top out and now it's up to \$335,000 and climbing.

In answer to Mr. Ellis, Mr. Marshfield said the brochures are displayed at their kiosks and available at local businesses. Some will be available around Delhi including in the display at the County Clerk's Office. He stated they had 5,000 brochures made.

Mr. Marshfield explained they hesitated to highlight businesses on the brochure because some of them are here today and gone tomorrow and then the brochure would be outdated.

WHEREAS, the revenues received under the Hotel Occupancy Tax during 2020 was set aside and placed into the Restricted Fund Balance (Hotel Occupancy Tax) for the purpose of the promotion and development of the tourism industry in Delaware County; and

WHEREAS, as of December 31, 2020, the Restricted Fund Balance (Hotel Occupancy Tax) had a fund balance of \$380,791.12; and

WHEREAS, a Project for the replacement of BIN 3352080, Knox Avenue over Wilson Hollow Brook, PIN 9754.77 ("the Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 95% Federal funds and 5% non-Federal funds; and

WHEREAS, the County of Delaware will design, let and construct the Project; and

WHEREAS, the County of Delaware desires to advance the project by making a commitment of 100% of the costs of the work for the Project or portions thereof.

NOW, THEREFORE, the Delaware County Board of Supervisors, duly convened does hereby

RESOLVE that the Delaware County Board of Supervisors hereby approves the above-subject project; and it is further

RESOLVED that the Delaware County Board of Supervisors hereby authorizes the County of Delaware to pay 100% of the cost of the Construction, Construction Support and Construction Inspection work for the Project or portions thereof, with the understanding that qualified costs may be eligible for Federal-aid, State-aid or reimbursement from Bridge NY funds; and it is further

RESOLVED that the sum of \$1,448,063.00 is hereby appropriated from 34-15112-54000000 and made available to cover the cost of participation in the above phase(s) of the Project; and it is further

RESOLVED that the Delaware County Board of Supervisors hereby agrees that the County of Delaware shall be responsible for all costs of the Project which exceed the amount of Federal-aid, State-aid or BY Bridge funding awarded to the County of Delaware; and it is further

RESOLVED that in the event the Project costs not covered by Federal-aid, State-aid or NY Bridge funding exceed the amount appropriated above, the Delaware County Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and it is further

RESOLVED that the County of Delaware hereby agrees that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months; and it is further

RESOLVED that the Chairman of the Board of the Delaware County Board of Supervisors be and is hereby authorized to execute on behalf of the County of Delaware all necessary agreements, certifications or reimbursement requests for Federal-aid and/or State-aid with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the County of Delaware's funding of Project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

In answer to Mr. Merrill, Commissioner of Public Works Susan McIntyre stated they are awarding to both bidders. Casings is the company that they are presently working with and have been working with for a number of years. Geiter Done is a new firm.

In response to Mr. Eisel, Ms. McIntyre confirmed Casings will still handle tire management.

Supervisor Valente shared that this company has a machine that they bring that will chip the tires on site.

In answer to Mr. Taggart, Ms. McIntyre stated they will have the tires chipped into 2-inch squares that will be used in lieu of stone aggregate. They have a rubber road on the landfill property that they use for their track equipment which has 6-inch spikes rather than tearing up the asphalt.

In response to Ms. Molé, Ms. McIntyre stated they would not be able to make rubber chips of playground quality because that requires significant magnetic separation to take out the wire beading.

In reply to Mr. Eisel regarding the pricing of Casings for towns, Ms. McIntyre stated they are revisiting those numbers and she will have a better answer at the next board meeting. Pricing for tires has steadily risen over the years and Casings' bid price is consistent to where it was at

just prior to DPW going out to bid so their price did not change based on the bid, however, their price has risen substantially over the years and she will give Supervisors an update at the next meeting.
