

**REGULAR MEETING**

**DELAWARE COUNTY BOARD OF SUPERVISORS**

**SEPTEMBER 22, 2010**

The regular meeting of the Delaware County Board of Supervisors was held Wednesday, September 22, 2010 at 1:00 p.m. in the Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, Chairman James E. Eisel, Sr. presiding.

The Clerk called the roll and all Supervisors were present except Mr. Donnelly.

Mr. Marshfield offered the invocation.

Mr. Homovich led the Board in the Pledge of Allegiance to the Flag.

The minutes of the August 25<sup>th</sup> meeting were accepted as presented. It was noted that the September 8<sup>th</sup> meeting was cancelled due to a lack of business.

The Clerk reported all other communications received have been referred to their respective committees for review.

Chairman Eisel granted privilege of the floor to the Director of Veterans' Service Agency John Boecke who presented Donna Elderkin as Employee of the Month.

Donna Elderkin began working for Delaware County in June 1990 as a typist for the Veterans' Service Agency. In January 2008 she was promoted to an administrative assistant and in September 2009 was appointed assistant to the director of Veterans' Service Agency. In this capacity she provides administrative support to the Director and assists the veterans' with a variety of entitlements earned through military service.

Mr. Boecke stated that Mrs. Elderkin is a true professional. Her sense of humor, mild manner and encouraging nature all contribute to her exemplary work performance. She develops good relationships with her clients, always cheerful and empathetic. Her flawless organizational skills, complete understanding of the Veterans' Agency benefit system, positive attitude and passion for what she does are an asset to the agency and community.

Mr. Boecke noted that Mrs. Elderkin was a tremendous support to him as he trained for the position of director. He thanked her for all she does for the county's veterans and congratulated her on her well deserved recognition.

Mr. Boecke presented Mrs. Elderkin with a \$100.00 savings bond.

Chairman Eisel presented her with the Certificate of Employee of the Month and thanked her for her dedicated service. He complimented Mrs. Elderkin for the great job she did when the agency was without a director.

Mrs. Elderkin stated that she felt privileged to be part of the Veterans' Service Agency and is very proud of the realm of services that the Agency offers. She thanked Mr. Boecke for his kind words and stated that it is a pleasure to work as a team to deliver the very best to our veterans and their families. She extended thanks also to the Board of Supervisors and the Department of Personnel for their support during the agency's transition last year.

Mr. Hynes, speaking as Chairman of the Planning, Recreation, Culture & Community Committee, stated that Mr. Boecke's management of the agency has increased efficiency tremendously. Working in cooperation with Mrs. Elderkin the agency is now servicing more veterans than they have in the past.

Chairman Eisel granted privilege of the floor to Mr. Valente. Mr. Valente introduced Delaware County Chamber of Commerce Executive Director Mary Beth Silano. Ms. Silano introduced Director of Tourism Patty Cullen, South Kortright Central School Superintendent Pat Norton-White and South Kortright Central School art teacher Anne Grohel.

Ms. Cullen noted that she asked her friend and art teacher Ms. Grohel if she would ask her art class to create travel posters depicting an aspect of living in Delaware County that is meaningful to them. Mrs. Grohel agreed and the students began creating prints that reflected scenes of the simple beauty of the mountains and the lands of Upstate New York, agriculture, hunting and the railroads.

The students inspired artwork was reproduced into posters and sold as sets with the South Kortright Central School receiving half of the proceeds to support their travel club.

Ms. Cullen presented the Board of Supervisors with six framed travel posters created by South Kortright Central School students, John Cianciullo, Beth Czaja, Katelyn Fletcher, Tallulah Guadagnino, Nicole Holdridge, Nicole Lennone.

Chairman Eisel applauded the project and on behalf of the Board thanked Ms. Cullen for the gift of the artwork which will be displayed in the lobby of the County Office Building.

Chairman Eisel granted privilege of the floor to Mr. Smith. Mr. Smith introduced Director of Cornell Cooperative Extension Jeannie Darling.

Mrs. Darling stated that Cornell Cooperative and 4-H Week will be celebrated in Delaware County during the week of October 3<sup>rd</sup> through 9<sup>th</sup>.

A slide presentation entitled: *Live Well, Grow Well ..Be Well*, was given detailing the

programs of Cornell Cooperative Extension (CCE) featuring each town in Delaware County and focusing on activities of agricultural competitiveness and profitability, children and youth, economic sustainability, environmental protection and enhancement, individual, family and community well-being and nutrition, health and safety.

Mrs. Darling thanked the Board of Supervisors, CCE's partners and volunteers who help make these programs possible.

Mrs. Darling introduced Senior Resource Educator Paul Cersoletti.

Mr. Cersoletti spoke of the decline in agriculture in New York State and in Delaware County but, noted that those who work in the field of agriculture know that Delaware County has a higher percentage of younger farmers than in any other part of the state. Our young folks have talent and commitment and he felt there was no better way to make that impression than to have one of the county's young farmers speak directly to the Board.

He introduced Dennis Deysenroth a young farmer whose family is participating in the Precision Feed Management Program. The Deysenroth family located in Bloomville have been successful dairy farmers for the past eight generations. Mr. Deysenroth explained what his family is doing today to position their farm in the future.

Mr. Deysenroth noted that their farm has always been productive but, over the past few years it has been rough financially. They have learned new methods and technologies to help make ends meet through the precision feed management team. Their cows are now grazed during the summer months which saves considerably on feed. Since the price of grain has gone up it made sense to grow grain. The family began making cheese which provided a greater return on their milk and now have a small business selling gouda cheese. This past January in response to requests for raw milk the family began selling their raw milk off the farm.

In answer to Chairman Eisel, Mr. Deysenroth said that they have been in the cheese business for about five years. The business started off slowly but, their cheese can now be purchased at local stores and farmers markets. This time of year more cheese is sold than in the winter months.

Mrs. Darling thanked Mr. Deysenroth for speaking today, adding that it is a pleasure to work with him and his family. What makes this family particularly special is that the children want to stay in agriculture.

Mrs. Darling said in response to Chairman Eisel, that the refreshments, a vegetable platter, cheese, quiche and zucchini bread are all made from locally grown products. She noted that fresh eggs are very popular and are selling well for those who provide them.

For standing committee reports, Chairman Eisel stated that effective October 1<sup>st</sup>, New

York State is going to charge sales tax on clothing. At this point in time, the county will not follow the state. As in the past, the county will not charge sales tax on clothing under \$110.00.

For standing committee reports Chairman of the Economic Development Committee Dennis Valente advised that the Revenue Plan passed by the Assembly and Senate and signed into law by Governor Paterson as part of the New York State 2010-2011 budget includes a new provision to limit eligibility for the Basic Star Program. Mr. Valente referenced the "*New Income Limit for Basic Star*" announcement placed on each of the Supervisor's desks and noted that there will be further information forthcoming from the state.

He also pointed out that the state has changed the way the towns have been processing the dog licenses. He remarked that these mandates are killing small government.

Mr. DuMond remarked that he sees these mandates as a further push towards regional government. The first steps in abolishing home rule and carrying the population out of Upstate New York. He believes it is time to stand up and begin protesting against this and any future mandates.

Mr. Valente noted that he was told when he asked about regional government at a statewide convention that town governments are inefficient. He pointed out that the Town of Davenport maintains 75 miles of vertical roads for \$5 a thousand, he has not seen state government maintain that kind of cost efficiency. Local government provides great service to its constituents and has nothing to be ashamed of.

Mr. Marshfield stated that the state still wants their cut even though they are doing nothing for it.

Mr. Valente pointed out that he was told by the state to budget \$1,000 in the towns' 2011 budget to cover postage alone. That is in addition to the cost of the new software program to track the dog licenses.

Mr. Valente felt these additional mandates will just make people more angry.

Mr. DuMond remarked that he hopes this is the final wake up call for people, the state is out of control. At this time he was unsure if the Town of Masonville was going to send the state any of their dog license money.

Chairman Eisel referenced an Action Alert placed on each supervisor's desk, entitled: *Action Needed to Oppose Efforts To Close Small Rural Post Offices*. He advised that there is a movement underway in Washington to close small rural post offices, especially if they are not profitable in an effort to help the Postal Service out of its financial predicament.

About ten years ago in the Town of Harpersfield there was an effort to close the post

office. The town fought to keep it open and won. This information is a heads up to what the federal government is considering. This is the time to write letters to our federal legislators letting them know how we feel about this matter.

**WHEREAS**, a Project for County Route 21 Corridor Study in the Towns of Franklin and Walton, Delaware County, P.I.N. 9752.90 (the Project) is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-Federal funds; and

**WHEREAS**, the County of Delaware desires to advance the Project by making a commitment of 100% of the Federal and non-Federal share of the Locally Administered costs of the Preliminary Engineering work; and

**WHEREAS**, the County of Delaware has previously executed Supplemental Agreement #1 and Master Federal Aid and Marchiselli Aid Project Agreement (D022081) for the Preliminary Engineering work and appropriated \$460,000.00.

**NOW, THEREFORE**, the Delaware County Board, duly convened, does hereby

**RESOLVE**, that the Delaware County Board hereby approves the above subject project; and

**IT IS FURTHER RESOLVED**, that the Delaware County Board hereby authorizes the County of Delaware to pay in the first instance 100% of the Federal and non-Federal share of the Locally Administered costs of Preliminary Engineering work for the Project or portions thereof; and

**IT IS FURTHER RESOLVED**, that the sum of \$15,000 is hereby appropriated from 34-15112-54000000 and made available to cover the cost increase of participation in the above phase of the Project; and

**IT IS FURTHER RESOLVED**, that in the event the full Federal and non-Federal share costs of the project exceeds the amount appropriated above, the Delaware County Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and

**IT IS FURTHER RESOLVED**, that the Chairman of the Delaware County Board of Supervisors be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the County of Delaware with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Municipality's first instance funding of project costs and permanent funding of the local share of Federal-aid and State-aid eligible Project costs and all Project costs within appropriations therefor that are not so eligible; and

In answer to Mr. Marshfield, Commissioner of Public Works Wayne Reynolds replied that the 20 percent non-federal funds will be the county's responsibility.

In reply to Chairman Eisel, Commissioner Reynolds explained that the state will pay 20 percent under the Marchiselli Program-Aid if there is a capital construction project attached. This is a study with no capital construction project planned.
