The Delaware County Board of Supervisors held a Public Hearing concerning Local Law Intro. No. 21 of 2023 in the Board of Supervisors' Room of the Senator Charles D. Cook County Office Building, 111 Main Street, Delhi, New York, at 1:00 p.m. on Wednesday, October 11, 2023, Chairman Tina Molé presiding.

Chairman Molé called the hearing to order and read the notice of public hearing:

No. 21 of 2023 for the proposed lease of a portion of certain real property owned by the County for the benefit of the County (hereinafter, the "County Property"), to Cellco Partnership d/b/a Verizon Wireless (hereinafter, "Verizon Wireless").

The property subject to the lease is located at No Number Pine Hill Road, in the Town of Sidney, Delaware County, New York, and includes space on the County communications tower for the placement of antennas and equipment of Verizon Wireless.
