Chairman Gladstone welcomed the new committee members. Chairman Gladstone introduced the meeting notes from December and January and all notes were approved by the committee.

**Emergency Services ---- Steve Hood, Director**

Mr. Hood asked for committee approval on overtime payment in lieu of comp time. Mr. Hood stated that this has to be done each year for personnel so that staff can take overtime in money instead of comp time. Supervisor Hinkley made a motion to accept and Supervisor Cetta seconded the motion, all were in favor.

Mr. Hood stated that January's number for ambulance are pretty consistent. Mr. Hood stated that numbers have continued to go up over the last 3 months. Headwaters in Stamford/Kortright is handling most of their BLS calls. We normally are sending ALS support.

Mr. Hood stated that there was nothing to report on the tower as waiting to hear back from the land owner about the property lines.

Mr. Hood stated that VFP went through all the tower site buildings and deemed it as condensation. The heat was not high enough in the building for the amount of equipment and space. We have turned up the heat in the building and dehumidifier seems to be working. Mr. Hood stated that they installed humidistats for the buildings and seem to have working in Davenport and Margaretville. Mr. Hood stated that Fishes Eddy was still having issues and they temperature got way low and thermostat had reboot itself. Mr. Hood stated they have fixed that problem and hopefully will adjust now.

Mr. Hood read through several bills that are looking to be passed in the Governor's budget this year.

Mr. Rossley was converting part of the multi-purpose room into a classroom for the new CAD. They have got most of the build out for the new cad operational but now doing live training and live building. This will continue straight through the summer with hopefully an August live date.

**Probation ---- Scott Glueckert, Director**

**Code Enforcement ----- Dale Downin, Director**

Mr. Downin stated that heat should be installed in the Bloomville building within the next couple of weeks.

Mr. Downin stated that Walton Building won't see heat until later on.

Mr. Downin stated that DSS building on main street they are trying to get the building set up.

Mr. Downin stated that the Homeless Shelter building went out for bid and haven't heard about the results. Chairwoman Molè advised they did receive bids back and they were all pretty good.

**Sheriff's Office ---- Craig DuMond, Sheriff**

Undersheriff Smith was present for Sheriff DuMond due to him being at the National Sheriff's Conference down in Washington, DC. Sheriff was having several meetings with different representatives and was excited to hopefully address some of the Public Safety issues.

US Smith advised that Sheriff DuMond was sworn in as President of the Sheriff's Association. He is very proud of this accomplishment, and is always saying put Delaware County on the map.

US Smith stated that we have recently brought on Retired Trooper Matthew Gombosi as a Special Patrol Officer who will be strictly assigned to Stamford Central School.

US Smith stated that we hired a new part time deputy who doubles as a Corrections Officer.

US Smith stated that we have chosen Deputy Cody Tromblee for the new investigator position that will be working with the DA's office working primarily on sex abuse cases in Delaware County.

US Smith advised about the annual Awards Ceremony for the Sheriff's Office and that it will be held February 26, 2024 at 2 PM.
