Delaware County Public Safety Meeting
Notes

November 6, 2023

The monthly meeting of the Delaware County Public Safety Committee was called to order by Chairman Gladstone at 11:30 A.M. in Public Safety Building 280 Phoebe Lane, Delhi, NY 13753 the following individuals were in attendance:

Chairman Gladstone introduced the meeting notes from October and will stand as submitted.

Emergency Services ---- Steve Hood, Director

Mr. Hood stated that the projects they have are moving forward.

Mr. Hood stated that the surveyor will be going to the property on the 20th and meeting the landowner to survey the road and property. Mr. Hood stated that they wanted the survey done and specked out over the winter so that they can break ground in spring.

Mr. Hood stated that the ambulance numbers are staying steady. The ambulance is back in Walton contracted with DVH. They have ability to do 911 calls that they are picking up for Walton and Trout Creek.

Mr. Hood stated that wait time isn't as long with the county ambulance in place.

Mr. Hood stated that there are 2 resolutions at the board meeting. One resolution is for a Homeland Security Grant of \$86,000 to be used towards the new CAD system.

Mr. Rossley stated that the first group of hardware should be sent in December and shouldn't have issues getting the equipment implemented. We are looking at January through August for a testing period and hoping to go live in August. This will include training all employees on the new system.

Mr. Hood stated that they are having good candidates with applications.

Mr. Hood stated that he worked with the finance committee and trimmed their budget down by a lot with allowing to keep the Capital Project Fund line open for the new site construction in Trout Creek.

Mr. Hood stated that Verizon is hoping to go live on the Grand Gorge Tower. Mr. Downin mentioned that they are good to go live on the Pine Hill tower he is just waiting for a new check to issue certificate. Mr. Hood stated that there has really been no interest in the towers. Supervisor Hinkley asked Mr. Hood if he minded him reaching out to the carrier to see if they have any interest. Chairman Gladstone state that AT&T was going to come to the Andes Town Board Meeting because they are saying that the tower that is there does not provide enough coverage that they are looking for.

Probation ---- Scott Glueckert, Director

Mr. Glueckert stated that he is working with case management software in making the transition from the server to the website based. Currently it is in the testing phase and should be done with everything from a week from today.

Mr. Glueckert stated that it is the same software just a different way of getting the information. This change will help probation officers do their work in the field instead of having to come back to the office to do their notes. They will also be able to see the case files when in the field as well.

Mr. Glueckert is still waiting to send back old cars to Enterprise. There was an issue with the titles and trying to work that out.

Mr. Glueckert stated that State Director of Probation announced that he would be retiring. He has been the Director since 2005 and there has not been any discussion about who might take over. Mr. Glueckert is thinking they will here sometime in February who might be taking over. Mr. Glueckert stated that Probation Directors concerns are that it is going to be someone appointed that has never been in the field and unaware of what they deal with. Mr. Glueckert is hoping for someone that will stand strong and back the departments.

Stop DWI ---- Scott Glueckert, Coordinator

Mr. Glueckert stated that there were 8 arrests for last month. Which 2 of these arrests were refusals, so we are still at about 25%.

Mr. Glueckert stated that he has received \$27,717 in fine revenue so far this year. He stated that there are two more fine revenue quarters to come from the local courts and should come in about \$50,000 that was budgeted.

Mr. Glueckert stated that anyone sentenced to state time we do not see the money for a while.

Mr. Glueckert stated that a bill is supposed to be passed next April that anyone charges with DWI will have to pay a \$195 mandatory surcharge that will go directly to Stop DWI.

Code Enforcement ----- Dale Downin, Director

Mr. Downin stated that he has communicated with the company bringing in the home for the DSS building. The building should be shipped this week.

Mr. Downin stated that the main street building is waiting for some testing to be finished.

Mr. Downin stated that they are pouring concrete at the Walton site.

Mr. Downin stated that they are doing the initial paving in Bloomville and will finish it in the spring. Mr. Downin is hoping the Bloomville building will be done next March next year. They will be doing all the interior during the winter and finish paving in the spring.

Mr. Downin is hoping the Walton building will be done June next year.

Sheriff's Office ---- Craig DuMond, Sheriff

Undersheriff Smith stated that the Commission of Corrections came to visit, and everything went well.

Undersheriff stated that we got another Full Time Deputy going to start last week of training. This deputy was a transfer in from another local agency but had worked in our Corrections Division prior to becoming a Police Officer.

Undersheriff stated that we attended several trunk or treat events, and handed out trick or treat bags for kids. Undersheriff stated that we participated in the Halloween around town for businesses. We also participated in Halloween safety patrols in schools.

Undersheriff stated that our Criminal Investigations Division completed a high-risk warrant which in turn arrested 2 people. There were several stolen items, firearms, and drugs involved. There are more charges pending as well. The CID had been working on this case for over a month.
